**AN ORDER IMPLEMENTING ONE WAY TRAFFIC ROUTES AT GILLE STREET
 AND PORTION OF SUNA STREET FOR THE UPCOMING KAAMULAN
 FESTIVAL 2016 AT THE MALAYBALAY CITY GRAND STAND**

WHEREAS, the Traffic Management Center (TMC) of the City of Malaybalay held a consultative meeting with the Office of the City Mayor regarding the probable traffic issues that may arise if the flow of traffic going to and out of the Grand Stand will not be regulated during the upcoming one month Kaamulan Festival 2016 celebration at the said area;

WHEREAS, in view of the foregoing and in consonance with the mandate of Section 16 of the Local Government Code of 1991, to enhance public health, safety, convenience, maintain peace and order, among others, thus the need to promulgate this order;

NOW THEREFORE, I, IGNACIO W. ZUBIRI, Mayor of the City of Malaybalay, by virtue of the power vested in me by law, do hereby order the implementation of the following traffic scheme, to wit;

Section 1. ONE WAY TRAFFIC ROUTES. (see Annex "A" for reference). All vehicles from Sayre Highway heading westward to the Grand Stand shall pass at Suna Street (entry point) and shall exit eastward at Gille Street to Sayre Highway;

Section 2. IMPOSITION OF FINES AND PENALTIES. Violations of the above provisions shall be considered prohibited for purposes of this period only and shall not be imposed any fine or penalty, *except*, for those acts and violations already defined and penalized by existing laws and ordinances;

Section 3. REPEALING CLAUSE. All orders and issuances, or parts thereof, which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

This order shall take effect on March 4 to April 2, 2016.

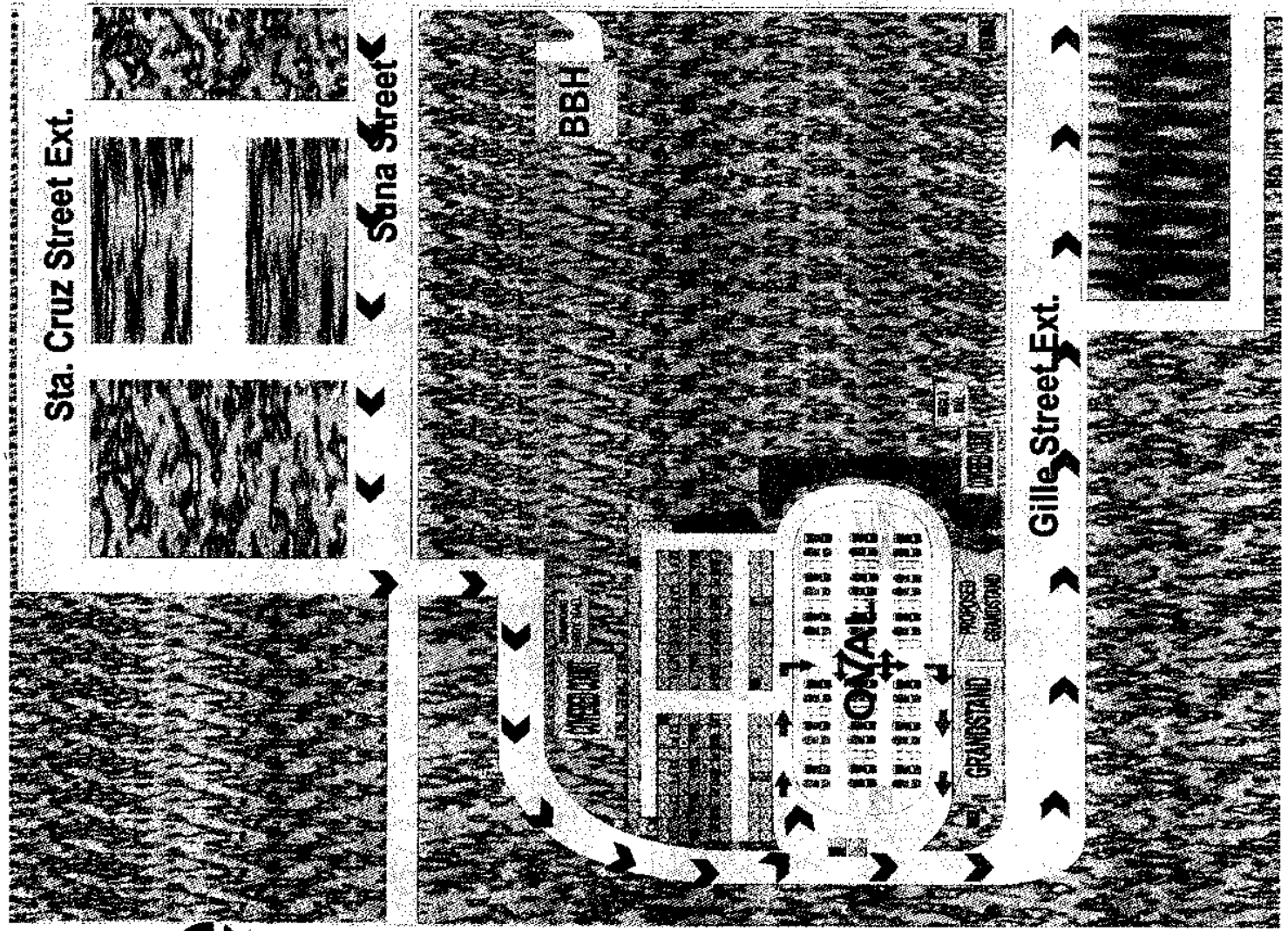
