

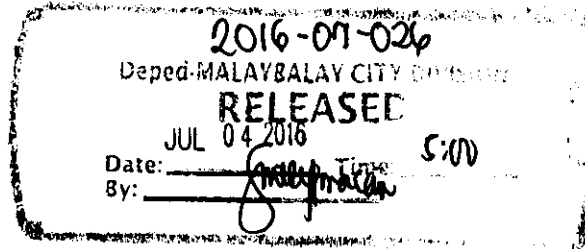

PROCLAMATION NO. 339

DECLARING THE MONTH OF AUGUST OF EVERY YEAR AS HISTORY MONTH,
THEREBY TRANSFERRING THE OBSERVANCE OF HISTORY WEEK FROM 15
TO 21 SEPTEMBER TO THE MONTH OF AUGUST

WHEREAS, History Week is observed from 15 to 21 September of every year by virtue of Proclamation No. 1304 (s. 1974);

WHEREAS, there is a need to transfer the observance of History Week from 15 to 21 September to the whole month of August and rename the occasion as "History Month" to emphasize the most significant turning points in Philippine history;

WHEREAS, major events in the nation's history occurred in the month of August which concludes with National Heroes Day on 30 August; and


WHEREAS, a week of observance is not enough to undertake various activities given the richness and diversity of our nation's history.

NOW, THEREFORE, I, BENIGNO S. AQUINO, III, President of the Philippines, by virtue of the powers vested in me by law, do hereby declare the month of August of every year as "**History Month.**"


Proclamation No. 1304 (s. 1974) is hereby repealed.

COMPETITION MECHANICS

I. GENERAL GUIDELINES

1. The competition is open to all Junior High School students from schools within Bukidnon.
2. Each participating school is allowed to send one (1) team composed of three (3) members regardless of year level.
3. The questions for the entire contest will cover the field of History (Please see list of topics on the second page). These questions will be from the Committee of the Histolympiad.
4. Clarifications regarding the rules of the competition shall be entertained by the Committee before the start of the Contest.
5. The registration fee is Php 300 per team (exclusive of snacks and lunch). This may be given on the day of the competition.
6. The contestants will be provided with pertinent materials needed for the competition.
7. Misbehavior of a team during contest, as determined by the proctors, is sufficient condition for disqualification of this team.
8. The mechanics of the contest are subject to change upon the discretion of the organizers.

II. DATE AND VENUE

The competition shall be on August 29, 2016 (Monday) at 8 o'clock in the morning. The contest shall be held at the University Convention Center (UCC).

III. CONTEST MECHANICS

1. The quizmaster will read each question twice.
2. All questions are multiple choices and will be projected on a wide screen.
3. The contestants should answer within the time allotted.
4. The quizmaster shall then read the answer of each of the given question.
5. Complaints must be aired before the next question is read. Only complains/inquiries from contestants on the stage and their respective coaches may be addressed or entertained by the panel of adjudicators. The decision given by the judges is final and is not subject to appeal.

A. Elimination Round

1. The Elimination Proper shall consist of two (2) rounds: Easy round and Moderate round
2. Each round has 15 questions and each question is worth 5 points and 7 points for Easy and Moderate respectively.
3. Ten seconds for the Easy and Moderate round are allotted per question. The timekeeper will give the signal at the end of the time limit.
4. At the end of the Easy Round, the teams who earned 35 points and above are qualified to advance in the next round. In case those which qualified are less than 10, then the first 10 teams who garner the highest scores shall advance to the Moderate round.
5. At the end of the Moderate round, the teams who earned 49 points and above shall advance to the Difficult/Final Round.
6. In case of a tie, a tie-breaker question shall be asked and the first team to earn a point is the one that shall qualify to the next round. Series of tie-breaker questions shall be given if necessary.

B. Difficult/Final Round

1. The Difficult/Final Round shall consist of ten (10) questions and participants are allotted 10 seconds to answer per questions. Each correct answer is equivalent to 10 points.
2. Points earned by the qualified contestants during the elimination round shall be disregarded.
3. The three finalists with the highest scores shall be declared as the champion, 1st runner up, and 2nd runner up, respectively.
4. In case of a tie, a tie-breaker question shall be asked and the first team to earn a point is the one that shall qualify to the next round. Series of tie-breaker questions shall be given if necessary.

IV. PARTICIPATING TEAMS

1. A team shall be composed of three (3) regular contestants and a coach.
2. The contestants must be officially enrolled students in the school they wish to represent.
3. All contestants must wear their school uniforms and must present school ID during the registration.

V. CONFIRMATION OF PARTICIPATION / SUBMISSION OF ENTRIES

Deadline of Confirmation of participation / submission of entries (complete names of the representatives / participants) shall be on or before August 22, 2016. VI. AWARDS / PRIZES

The Champion, 1st runner-up and 2nd runner-up will receive cash, medals and Certificate of Recognition.

All students, coaches and participating schools shall each receive a Certificate of Participation.
