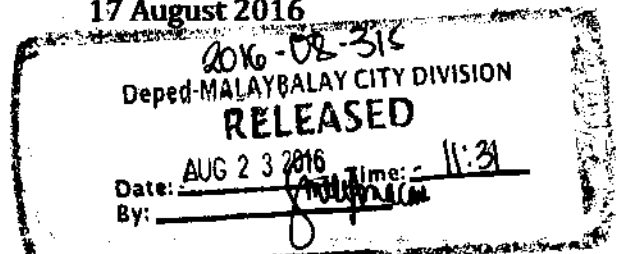

1. In compliance with DepEd Order No. 14, s. 2015 entitled *Authorizing the Collection of Fees for the Legal Research Fund (LRF)*, the Department of Education (DepEd) Regional Office 10 issues the enclosed additional fees from among the imposed fees collected by the Office.
2. This is in support of Republic Act (RA) No. 3870 (*An Act Defining the Functions of the U.P. Law Center, Providing for Its Financing and for Other Purposes*) for the University of the Philippines (UP) Law Center to conduct legal research, law reform, and continuing legal education, among other purposes.
3. Further, Presidential Decree (PD) No. 200 (*Amending Section 4 of Republic Act No. 3870*) and PD No. 1856 (*Providing for the Financial Support to the U.P. Law Complex and Further Amending for this Purpose RA No. 3870, as Amended*) mandate the collection of an additional fee of one percent (1%) for each filing fee imposed, but in no case lower than Ten Pesos (P 10.00) for the Legal Research Fund (LRF). These desired fees shall support the UP Law Center and the University of the Philippines Law Complex for its financing and other purposes.
4. Immediate dissemination of and strict compliance of all concerned is directed.
