RECONSTITUTION OF A TECHNICAL WORKING GROUP FOR THE EDUCATION OF UNDOCUMENTED FILIPINO CHILDREN IN SABAH, MALAYSIA

Pursuant to Article VI of the Memorandum of Understanding between the Cooperation, a Joint Working Group (composed of delegates from both governments) convened on April 16, 2015, the Philippine delegation last year was composed of the following:

- In view of the change in the administration and in the efforts to continuously address the education concerns of undocumented Filipino children, among others, in Sabah, Malaysia, a Technical Working Group (TWG) is reconstituted. The reconstituted TWO shall represent the Philippines in the 2nd meeting of the Joint Working Group this year which will be held in Malaysia.
- 3. This TWG shall have the following functions and responsibilities:
 - a. study the issues and concerns relating to the education of undocumented children in Sabah, Malaysia;
 - b. identify solutions to address the issues and concerns for recommendation to the DepEd Secretary;
 - c. establish a strategic plan, which includes short and long-term plans, to address the issues and concerns relating to the education of the undocumented children in Sabah, Malaysia;
 - d. implement, monitor and evaluate, in coordination with offices concerned, the strategic plan for the undocumented children;
 - e. incorporate the budgetary requirements of the strategic plan in the respective office budget of each TWG member;

- f. establish partnerships and linkages with the Malaysian Government;
- g. harness the support of other Philippine Government agencies to address the issues and concerns;
- h. coordinate with the Philippine Embassy in Malaysia;
- i. propose to the DepEd Secretary policy and legislative recommendations to address the education of the undocumented children in Sabah; and
- j. submit reports to the DepEd Secretary.
