**POSTPONEMENT OF THE ADMINISTRATION OF THE 2016 PHILIPPINE
EDUCATIONAL PLACEMENT TEST**

To: Regional Directors
Schools Division Superintendents

1. As per DepEd Order No. 55, s. 2016 entitled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program, the Philippine Educational Placement Test (PEPT) shall be administered annually every third Sunday of November for Luzon Cluster and fourth Sunday of November for Visayas and Mindanao Clusters. However, due to administrative and logistical limitations, the test shall be moved indefinitely. A memorandum will be issued specifying the new dates of test administration.
2. Consequently, registration of examinees is hereby extended until further notice.
