

 - 1.4 Visit to the Home of the Elderly, Rehabilitation Centers or Prisons:
 - 1.5 Medical and Dental Missions (in coordination with the concerned agencies); and
 - 1.6 Other similar activities.
- 2. Moreover, this Office reiterates the following Department policies adopted by this Region:

- 2.1 Decorations in the offices and schools should be inexpensive, and to the extent possible, produced by employees and students using recycled materials;
- 2.2 Contribution for celebration in offices or schools, whether in cash or kind should be strictly voluntary;
- 2.3 Disruption of academic activities in schools and delivery of Department services should be minimized.
- 3. Schools Heads are directed to submit a consolidated Compliance Report to this Memorandum in both the public and private schools following the format attached as Annex "A". Deadline for submission of the Compliance Report is **on or before January 10, 2017.** Attention: Marsfifth M. Mamawag, EPS II-Social Mobilization.


