

- Provide administrative and technical support to all SBFP schools' compliance to guidelines, adherence to procurement process, ensure timely release of SBFP funds to schools and prompt liquidation of SBFP funds by the schools concerned.
- Monitor monthly compliance of schools to SBFP guidelines, procurement process, health and nutritional assessment, start and conduct of DAILY feeding activity with its complementary activities on Essential Health Care Program (EHCP) which include deworming of SBFP beneficiaries, handwashing and tooth brushing as part of feeding activity.
- Observe and advise integration of good grooming, personal hygiene and productivity, life and values development training.
- Monitor sustainability of food production projects, waste segregation and composting as complementary activities.
- Perform other tasks relevant to SBFP implementation.
