

RDC-X NOW ACCEPTS APPLICATIONS FOR MEMBERSHIP REPRESENTING THE PRIVATE SECTOR FOR TERM 2016-2019

The Regional Development Council-X (RDC-X), the highest planning and policy-making body in the region, now invites applicants for membership representing the private sector for Term 2016-2019. A PSR applicant or nominee must have the following qualifications:

- Filipino citizen, of legal age, not disbarred by law to participate in government and the electoral processes;
- 2. A resident of the region in the last three (3) years:
- 3 Willing and able to participate in all RDC activities and with a proven track record in socioeconomic development in the region;
- 4. Must not hold any government position and must not receive any remuneration from the government while serving as PSR to the RDC:
- 5 Must be nominated by an accredited Private Sector Organization

A Private Sector Organization applicant for accreditation by the RDC-X must meet the following:

- Adherence to the Philippine Constitution.
- Must not be blacklisted by any government agency or instrumentality.
- 3. Legal Personality Must be registered with the Securities and Exchange Commission (SEC) or any government agency that registers organizations and associations for the purpose of bestowing legal personality.

Civic clubs, branches and affiliates of organizations with no SEC registration may submit a certification from their mother institution/head of office based elsewhere that they are bona fide extension of their organization and that the

PSO is authorized to represent the organization in the RDC. Said PSO must have an office address in Region X (Northern Mindanao).

- 4. Performance. PSO must have conducted socio-economic activities for at least three (3) years from date of registration in the region. Activities and area of influence must involve a city or municipal capital of provinces. The socio-economic development activities must have been implemented in close coordination with local government units or other private sector organizations.
- 5. Nationality. The PSO must be managed by Filipinos. Organizations with government officials and employees as ex-officio members of the Governing Board, or whose operations are funded by the government, are disqualified. Financial support by the government to specific projects will not be considered as funding support to operations.

REQUIREMENTS:

- 1. Accomplished Private Sector Organization Profile Sheet (Form 1)
- 2. Accomplished FSR Naminee Profile Sheet (Form 2)
- 3. Accomplishment Report for the past three years
- SEC Registration and Certification from any government agency or certification from the mother institution.
