

LOCAL) AND CLASSES IN PUBLIC SCHOOLS AT ALL LEVELS

1. Pursuant to the herein Presidential Proclamation No. 319 and Memorandum Circular No. 26 issued on September 19, 2017 declaring Thursday, 21 September 2017, as a **National Day of Protest**, this Office hereby reiterates the suspension of work in the government offices, in the National level and classes in the public schools at all levels on September 21, 2017.

It is also reiterated that "agencies whose functions involve the delivery of basic and health services, preparedness/response to disasters and calamities, and/or the performance of other vital services are hereby directed to provide stand-by emergency near protest sites and areas of mass action".

#### MEMORANDUM CIRCULAR NO. 26

In view of the Proclamation issued by the President declaring 21 September 2017 as a National Day of Protest, and the expected public railies, marches, demonstrations, and other mass actions in various parts of the country, work in government offices, both national and local, and classes in public schools at all levels, including state universities and colleges, are hereby suspended on 21 September 2017.

Agencies whose functions involve the delivery of basic and health services, preparedness/response to disasters and calamities, and/or the performance of other vital services, such as, but not limited to, the Department of Health, the Department of Social Welfare and Development, the Bureau of Fire Protection, and the National Disaster Risk Reduction and Management Council, are hereby directed to provide stand-by emergency assistance near protest sites and areas of mass action.

The suspension of work in private companies and classes in private schools in affected areas is left to the sound discretion of their respective heads.

#### PROCLAMATION NO. 319

### DECLARING THURSDAY, 21 SEPTEMBER 2017. AS A NATIONAL DAY OF PROTEST

WHEREAS, Article II of the 1987 Constitution states that the prime duty of the Government is to serve and protect the people, and that the State values the dignity of every human person and guarantees full respect for human rights.

WHEREAS the Martia Law era that began with the promulgation of Problamation No. 1081 is 1972) has imprinted itself in the collective memory of the people as a time attended by the commission of gross number rights violations arbitrary state interventions, rampant corruption, and disregard of fundamental civil liberties.

WHEREAS, this Administration recognizes the fear and indignation of the people against a repetition and perpetuation of such human rights violations and all office failings of the government.

WHEREAS, Article III. Section 4 of the 1987 Constitution guarantees the people's freedom of speuch and the right to peaceably assemble, as well as to pelition the government for redress of grievances.

WHEREAS, Executive Order No. 292 is 1987) provides that the President may by way of a proclamation ideclare a status or condition of public moment or interest;

NOW, THEREFORE, I, RODRIGO ROA DUTERTE, President of the Republic of the Philippines by virtue of the powers vested in me by the Constitution and existing laws, do hereby declare Thursday, 21 September 2017, as a National Day of Protest, in solidarity with the people's call against all excesses and shortcomings of the government, and with the people's desire to uphold the highest standards of integrity, efficiency and accountability in government.

I urge all protosters to act within the bounds of the law maintain a peaceful conduct of rallies marches and demonstrations be vigilant of possible infiltrators who may instigate violence in an effort to provoke the police and other raw enforcement authorities, and avoid causing any undue inconvenience to their fellow citizens.

I hereby order all police and other law enforcement authorities to observe maximum restraint and maintain such distance from these assembles and mass actions as may be necessary to allow protesters the full exercise of their rights within the bounds of the law.

I enjoin all local government units to dispense with the permit requirements for holding public assemblies marches and demonstrations in areas within their jurisdiction during this National Day of Protest.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
