#### **RESOLUTION No. 3, Series 2017**

A RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION OF THE PROVINCE OF BUKIDNON TO ALLOW THE TECHNICAL VOCATIONAL INSTITUTIONS TO PROMOTE AND MARKET THEIR TESDA REGISTERED PROGRAMS TO THE NATIONAL HIGH SCHOOLS IN BUKIDNON

- WHEREAS, the Bukidnon TVET Institutions Association has been TESDA-Bukidnon's cohesive partner in the delivery of quality TVET has committed to work together on areas of unity and cooperation between and among them to ensure efficient and effective implementation of TVET in the province;
- WHEREAS, the TVET Sector of the province has expressed concern regarding its advocacy efforts in the promotion of TVET to National High Schools for the Senior High School programs;
- WHEREAS, some of the Technical Vocational Institutions reported past experiences that they were denied by DepEd in the province to promote and market their registered TVET programs to the SHS;
- WHEREAS, the Technical Vocational Institutions and TESDA Technology Institutions are supposed to be DepEd's partner in the delivery of quality TVET, hence, a partnering scheme and policy guidelines can be agreed by DepEd Bukidnon and TESDA Bukidnon on the Partnering with Technical Vocational Institutions (TVIs) for the use of workshops/laboratories, trainers, provision of SHS program and other arrangements;
- WHEREAS, among other arrangements that can be made is to allow expertise of TVET trainers in development of leaners materials and teachers' guides;
