

STRENGTHENING THE UTILIZATION OF LEARNING RESOURCE FROM THE OFFLINE AND ONLINE LR PORTAL OF THE DEPARTMENT OF EDUCATION IN TIMES OF DISASTER OR EMERGENCIES

Please be reminded that in times of disaster or emergencies Department Order No. 37, series 2015 re: The Comprehensive Disaster Risk Reduction and Management guides the Department towards resilience-building in offices and schools, to ensure that quality education is continuously provided and prioritized even during calamity.

One of the objectives of the said framework is to plan for educational continuity in the face of expected hazards and threats where the reinforcement of at least one of the education outcomes such as Access, Quality and Governance is targeted. This can be done through the utilization of learning resources from the Irmds.deped.gov.ph as an online source or from the offline portal of Learning Resource Management and Development System (LRMDS). The said offline Learning Resources (LR) could be accessed even without the internet connection aside from the fact that all Division LRMDS Manager/Coordinator were provided copies of the LR with the advice to provide copies to all the schools.

Finally, the offline LR could also be accessed from the DepEd Computerization Program (DCP) Packages where all learning resources from LR Portal were built-in in every computer equipment delivered to the school.
