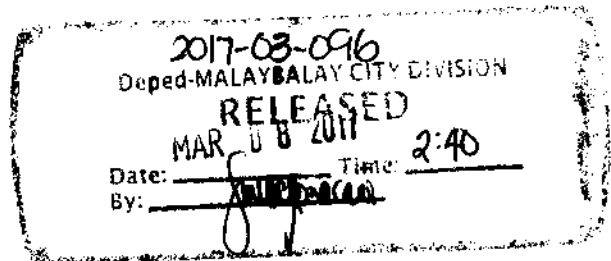

SUBJECT: SY 2016- 2017 TEACHING AND NON-TEACHING PERSONNEL ANNUAL PHYSICAL EXAMINATION

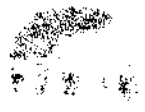
1. Parallel with DM no. 22, s. 2015 re: **Annual Physical Examination of DepEd Employees (Teaching and Non-Teaching Personnel)** and in compliance with Civil Service Commission (CSC) Memorandum Circular No. 17, s. 1989, **all Division teaching and non-teaching employees** are advised to undergo physical examination for SY 2016-2017 as part of the personnel clearance from accountabilities.

2. Along this context, all personnel are encouraged to avail of the OUT PATIENT services of **Tamang Serbisyong Kalusugang Pampamilya (TSEKAP)** formerly known as Primary Health Care Benefit (PCB) Package and submit **Annual Health Examination Form 86**. This shall be filled out by the **City Health Physician (CHO)** for **newly hired personnel for the TSEKAP enlistment**, while **permanent employees who were already enlisted last school year may visit CHO or any government-licensed physician for the annual health clearance**.
