

- As embodied in DepEd Order No. 44 s. 2016 re: Guidelines on the School-to-School Partnership for Fiscal Year 2016, one of the eligible activities of the schools involved is the development of the contextualized learning materials for MTB-MLE in key stage K-3, In view of this, the Division LRMDS supports this activity through the evaluation/quality assurance and validation of the teacher-developed Big books as one of the outputs of STS Partnership program.
