- 1. The National Commission for Culture and the Arts (NCCA)-National Committee on Dance will conduct the **Dance Echange: The Philippine International Dance Workshop and Festival** from May 8 to 11, 2017 in Ilagan City, Isabela.
- 2. The Dance Xchange aims to:
 - a. give the participants an opportunity to interact and learn among dancers, directors, and dance choreographers from the different countries, including the Philippines;
 - b. provide enriching activities for choreographers, teachers of Physical Education (PE) or Music, Arts, Physical Education and Health (MAPEH), Special Program in the Arts (SPA), Arts and Design Track of the Senior High School (SHS), dance trainors, and students;
 - c. provide them with new ideas and inspiration, which will stimulate the creativity of choreographers, dance directors, dancers, and dance teachers;
 - d. showcase the unique dances of each country;
 - e. strengthen the network among international dance organizations towards stronger cultural relations among participating countries; and
 - f. utilize dance as a tool for cultural exchange and sharing.
- 3. The Dance Xchange will have activities such as artists' forum, dance workshops to be conducted by directors of the participating countries, festival of dance performances, major concerts, outreach performances, master classes and cultural tours.
- 4. The participants of this activity are teachers of MAPEH, SPA, Arts and Design Track of the SHS, dance trainors, choreographers, and directors of dance groups of the schools, and dancers. The attendance of public school teachers and staff shall be on official time only.

- 5. A registration fee of Two Thousand Pesos (P 2,000.00) will be charged to each participant to cover expenses for kits, IDs, certificates, T-Shirt, and other materials. The amount will not cover food and accommodation of the participants.
