

- 1. Relative to DepEd Memorandum No. 98, s. 2017 entitled *Emergency Measures* in Response to the Marawi Situation, the Department of Education (DepEd), in consultation with DepEd ARMM and the ARMM Government and upon the recommendation of the relevant security agencies, **postpones indefinitely** the opening of classes in the entire Division of Marawi City, as well as in the Districts of Ditsaan Ramain I, Ditsaan Ramain II, Ditsaan Ramain III, Marantao I, Marantao II, Saguiran I, Saguiran II, and Saguiran III in the Division of Lanao del Sur, in light of the continuing security considerations in the area.
- 2. Opening of classes in the abovementioned areas will be decided and announced in consultation with DepEd-ARMM and the ARMM Government, and upon the recommendation of the relevant security agencies.
- 3. All other provisions of the said Memorandum remain in effect.
- 4. Immediate dissemination of this Memorandum is desired.
