On May 30-31, 2017, a Senior High School (SHS) meeting was conducted to discuss ongoing Senior High School (SHS) tasks and policies, and to synchronize the flow of SHS processes in the central and regional offices.

The following are the agreements on SHS program offerings:

- 1) Requests for changes in program (track/strand/specialization) differings for SY 2017-2018 that were submitted to the Central Office, as long as validated and endorsed by the Regions, are good as approved.
- 2) Succeeding requests for changes in program offerings will be approved by the Regions except for unique tracks such as Maritime, and new offerings that are not presently part of SHS program offerings. Requests for new or unique tracks have to be endorsed by the Region to the Central Office through the Bureau of Custiculum Development (BCD).
- 3) All other concerns with regard to SHS that cannot be addressed by the Regions will be forwarded to the Office of the Undersecretary for Planning and Field Operations.
