On the other hand, non teaching staff shall be provided with Compensatory Time-Off (CTO) per Civil Service Commission (CSC) and the Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non Monetary Remuneration for Overtime Service Rendered.

- 4. Meals, materials and supplies for the conduct of the said activity shall be charged to the Regional Office funds. While travelling and other incidental expenses shall be charged to local funds subject to the usual accounting and auditing rules and regulations.
