DepEd MEMORANDUM No. 45 s. 2017

GUIDELINES ON THE UTILIZATION OF FISCAL YEAR 2017 ADOPT-SCHOOL PROGRAM SUPPORT FUNDS

To: Undersecretaries
Assistant Secretaries
Bureau and Service Directors
Regional Directors
Schools Division Superintendents
All Others Concerned

- 1. The Department of Education (DepEd) is continuously improving partnership building and linkages through the Adopt-a-School Program (ASP) under the External Partnerships Service. The Program aims to obtain support from public and private entities to provide additional resources that will improve learning environment and expand access to quality education service for learners in public schools.
- 2. To scale up and sustain partnership initiatives at the regional and schools division levels, DepEd provides financial subsidy or ASP Support Fund.
- 3. The 2017 ASP Support Funds amounting to One Hundred Fifty Thousand Pesos (P 150,000.00) for the regional offices, and Seventy Five Thousand Pesos (75,000.00) for the school division offices, shall be downloaded through (Sub-ARO) issuance. The list of implementing regional and schools division offices, each of which with a corresponding allocation, is contained in Enclosure Nos. 1 and 2.
- 4. The downloaded support funds shall be used for the following purposes:
 - a. Orientation of school heads on ASP, *Brigada Eskwela* Program and relevant Partnership Guidelines;
 - b. Brigada Eskwela monitoring and evaluation activities;
 - Brigada Eskwela Awards Program at the schools division and regional levels;
 - d. Stakeholders' Forum and Partnership Appreciation Program at the schools division and regional levels;
 - e. Partnership building and planning activities at the schools division and regional levels; and
 - f. Other activities related to partnerships and external linkages.
- 5. The following objects of expenditure shall not be allowed under the subsidy:
 - a. Personal Services such as salaries, overtime pay and honoraria;
 - b. Operational Expenses such as utilities (water, electricity, internet connectivity, among others) funded from the regular Maintenance and Other Operating Expenses; and
 - c. Capital Outlay, such as purchase of equipment and gadgets.

- 6. The Physical and Financial Accomplishment, which reflects the activities undertaken through out the year shall be submitted, using the format provided in Enclosure No. 3, to External Partnerships Service, DepEd Central Office, Teodora Alonzo Bidg., DepEd Complex, Meralco Avenue, Pasig City.
- 7. The submission of budget utilization or liquidation report to regions and schools divisions is stated until first week of December 2017.
- 8. Non-compliance may result in the suspension of the financial subsidy.
- 9. Immediate dissemination of this Memorandum is desired.
