- 1. Pursuant to DepEd Order No. 34, s. 2017 entitled Guidelines on the Formation of Consultative and advisory Bodies [CABs] on Indigenous Peoples Education [IPEd] in Regions implementing the IPEd Program and consistent with the Rights-Based Approach [RBA] as articulated in the National IPEd Policy Framework and DepEd Order No. 32, s. 2015 entitled Adopting the Indigenous Peoples Education [IPEd] Curriculum Framework, the Division of Malaybalay City will conduct the Orientation on Consultative & Advisory Body for IPEd and Formation of Division CAB on December 8, 2017 at Sumpong Central School, Malaybalay City.
- 2. The objectives of the activity are the following:
 - a] provide orientation on the formation of the Consultative Advisory Bodies [CABs];
