

DIVISION TRAINING-WORKSHOP ON DEPED CHILD PROTECTION

POLICY (D.O. 40, S. 2012), ANTI-BULLYING ACT AND ITS IRR (RA 10627 & D.O. 55, S. 2013) AND DEPED GUIDELINES AND PROCEDURES ON THE MANAGEMENT OF CHILD-AT-RISK (CAR) AND CHILDREN IN

CONFLICT WITH THE LAW (CICL) (D.O. 18, S. 2015)
