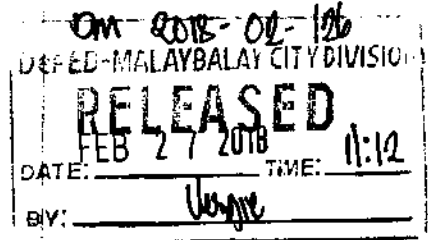

SUBJECT: 2018 DIVISION ANNUAL SEARCH FOR GULAYAN SA PAARALAN
BEST IMPLEMENTER

1. Pursuant to DepEd Order No. 223, s. 2016, re " Strengthening the Implementation of the Gulayan sa Paaralan Program in the Public Elementary and Secondary Schools Nationwide", this Office announces the full implementation of the said program. In lieu of this, a Search for the Best Implementers Schools of Gulayan sa Paaralan Program (GPP) for SY 2017-2018 shall be conducted on February 28, 2018 to March 2, 2018.
2. All Districts are encouraged to recommend two (2) entries from the Elementary School Category and one (1) from the Secondary School.
3. Each school entry shall have a minimum of 200 square meters' area. Recommended vegetables to be planted in the school garden are vegetable plants that can help address malnutrition problems in schools.
4. This year's GPP evaluation, the evaluation team are composed of the following: Luis S. Alajar Jr as Chair/Team leader, Carlos G. Rara -Co-chair, Romil T. Jabonero-Vice Chair, and City Agriculture Representatives- Members. Travel and other incidental expenses relative to the activity shall be charged to local funds subject to usual accounting and auditing rules and regulations.
5. All harvested vegetables shall be properly recorded by the School GPP Coordinator with pictures (before and during) with the pupils/students and teachers. This will be reflected in the record book as to total number of kilos of vegetable harvested for feeding program, number of kilos sold to the pupils, students, teachers and community. The Criteria for evaluation is stipulated in Enclosure No.1 to this Memorandum (see attached).
