

## ENJOINING GOVERNMENT AGENCIES AND LOCAL GOVERNMENT UNITS TO PROVIDE RDC-X WITH REPORTS ON THE IMPLEMENTATION OF JMC 2012-01 (FOR RLAs) AND JMC 2013-01 (FOR LGUs)

- WHEREAS. Joint Memorandum Circular (JMC) 2012-01 of the Philippine Commission on Women (PCW). National Economic and Development Authority (NEDA) and Department of Budget and Management (DBM) prescribed guidelines for government agencies instrumentalities on the Preparation of Annual Gender and Development (GAD) Plans and Budgets and Accomplishment Reports to Implement Republic Act 9710 or the Magnet of Women;
- WHEREAS, JMC 2013-01 of the PCW. Department of the Interior and Local Government (DILG), DBM and NEDA also prescribed guidelines for local government units (LGUs) on the Localization of the Magna Carta of Women:
- WHEREAS, JMC 2012-01 was issued to ensure the promotion of equal gender opportunities in all spheres of public policies and programs by ensuring that GAD concerns are incorporated and reflected in agencies' performance commitment contracts, annual budget proposals, and work and financial plans; JMC 2013-01 was also issued to ensure that GAD is mainstreamed in local policy-making, planning, programming, budgeting, implementation, monitoring and evaluation and that LGU efforts on GAD are aligned with that of the National Government and its commitments to international declarations;
- WHEREAS, RDC-X Resolution No. 40, s. 2016 confirmed the RDC-X MacroCom to also serve as the Regional Gender and Development Committee (RGADC) a body prescribed by NEDA and PCW to initiate, coordinate and monitor, among other functions, gender mainstreaming at the sectoral and regional levels as mandated under RA 9710;
- WHEREAS, the RGADC is also tasked to prepare and submit reports on the status of implementation of the Magna Carta of Women and other GAD initiatives in the region following the guidelines set by the PCW and other government oversight agencies:
- THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the region's national government agencies and the LGUs are enjoined to submit annual reports pertinent to the implementation of the above JMCs by the end of the first quarter of each year beginning 2018 to RDC-X through the NEDA-X as the RGADC-X Secretariat:




