CLEAN-UP OF SALARY DEDUCTIONS

To: Schools Division Superintendents

This Region

- 1. In view of the strict implementation of Section 48 (Authorized Deductions) of the FY 2018 GAA General Provisions, the Department is taking steps to ensure that deductions in the pay slips of personnel are valid and legitimate.
- 2. A clean-up of salary deductions of whatever nature, whether loan amortizations, premia, membership contributions/dues, or others, shall be done to stop possible invalid and illegitimate deductions. Individual employees are expected to accomplish and submit the template below to report such deductions to the Regional Payroll Service and request removal of the same:
