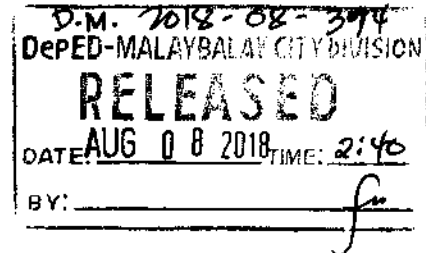

To: **Schools Division Superintendents**  
*This Region*

1. Pursuant to RA 9165 on the Comprehensive Dangerous Drugs Act of 2002 and the Dangerous Drug Board (DDB) issuance of Board Regulation No. 5, series of 2007 on Institutionalizing the Barkada Kontra Droga Program, the Department of Education-Region X, through the Education Support Services Division (ESSD) – Health and Nutrition Unit, will conduct the **Search for the Outstanding Barkada Kontra Droga Implementers in Secondary Schools for School 2017-2018**.
2. The search aims to achieve the following:
  - a. Strengthen the National Drug Education Program (NDEP) through the BKD movement established in schools;
  - b. Develop skills and understanding among students, faculty, and school administrators in initiating active responses for a drug-free school;
  - c. Increase community awareness and participation resulting in maintaining a fully-free environment in the school, home, workplace, and community;
  - d. Support and sustain the services in the Barkada-adopted concepts among educators, professionals, families, work forces, peer groups, and other sectors; and
  - e. Identify best practices of the different BKD chapters, which will serve as models for other schools to implement.
3. The search will cover BKD activities conducted from June 2017 – ~~June 2018~~ Division entries shall be submitted to the Regional Office X – ESSD on or before August 20, 2018. The winner of the Regional level will be the entry of Region X for the national search.

PROGRAM IMPLEMENTERS IN THE SECONDARY SCHOOLS**

**School Year 2017-2018**

**IMPLEMENTING RULES:**

• **Who can participate**

The Search for the Outstanding BKD Chapter is open to all secondary schools with an organized and functional BKD Chapter.

• **Period of Coverage**

**The Search will cover BKD activities conducted from June 2017 to June 2018**

**There will be three (3) levels of searches to be conducted as follows:**

1. **Division Level** – The search will be conducted in July 2018 by the Division Evaluating Team. The winner at the respective Division level shall be submitted to the Regional Office on or before August 20, 2018.
2. **Regional Level** – The search at the regional level will be done in August 2018 which the best entry in each region shall be submitted to the National Evaluation Team on September 20, 2018.
3. **National Level** – National Evaluation will be from October to November 2018 in which five (5) Outstanding BKD entries shall be chosen.

• **Criteria**

1. **Functionality of the BKD Program on Drug Abuse Prevention (10%)**
  - a. Activities / Timetable **10%**
2. **Coverage and Scope of Implementation (20%)**
  - a. School-wide Implementation **10%**
  - b. Community involvement and partnership **10%**
