 - Copies of service records, performance rating, and school clearance for those with teaching experience.
 - Certificates of specialized training, if any
 - Certified copy of the Voter's ID
 - NBI Clearance
 - Omnibus certification of authenticity and veracity of all documents submitted, signed by the applicant

Additional requirements

- Certified photocopy of General Weighted Average from the Registrar of the school where the applicant graduated.
- 5. It is further advised that all qualified applicants shall take the English Proficiency Test (EPT) on September 22, 2018 at Casisang Senior High School designated rooms. Applicants who have previously taken the test shall have the option to retake with the condition that the latest result will be considered in the computation.
