B. Qualifications of the 2018 Principals' Test Applicants: (Must be any one of this)

- 1. One year as Head Teacher; or
- 2. Two years as Teacher-in-charge, or
- 3. Two year as Master Teacher, or
- 4. Five years as Teacher III or SPED teacher, or
- 5. Five years as incumbent public school teacher who has five years managerial and Supervisory experience in a DepED recognized private institution or Commission on Higher Education (CHED) recognized higher education institution.
- 6. Education Program Specialists and Senior Education Program Specialists with fiveyear teaching experience (private or public teaching experience).
- 7. Those who failed to pass the 2015, 2016 and 2017 Principals' Test.

C. Required Documents of each 2018 Principals' Test Applicant:

- 1. Official DepED email account. (May be requested for activation and creation from respective Information Technology Officer).
- 2. Approved Individual Performance Commitment and Rating Form (IPCRF) with a rating of at least Very Satisfactory (VS) in the last two (2) consecutive rating periods duly certified by the authorized personnel in the Schools Division Office.
 - Teacher in Charge (TIC) and Head Teachers (HT) acting as school heads are required to secure Office Performance Commitment Rating Form (OPCRF); and
- 3. Service Record duly signed by the Administrative Officer V (Chief Administrative Officer) of the Schools Division Office (Regional Office).

IF APPLICABLE:

- 4. Designation Order as Teacher in Charge (TIC) or Officer in Charge (OIC) signed by the Schools Division Superintendent;
- Certification of managerial and supervisory experience from DepED-recognized private institution or CHED-recognized higher education institution signed by the School Director or School Head.

Once the Application is Approved for Payment:

- 1. Submit the hard copy of the required documents.
- 2. 2 passport size (4.5 cm. x 3.5 cm.) ID pictures taken within the last 6 months with signature over complete name.
- 3. Examination Fee of Five Hundred Fifty Pesos (Php. 550.00)


