- 1. Pursuant to the Regional Memorandum No. 499, s. 2018 re: 2018 Regional Schools Press Conference (RSPC) on December 11-14, 2018 at Tangub City, this Office hereby conducts a Division Enhancement Training for School Paper Advisers and Campus Journalists on October 26-27, 2018. - 5. Each participant shall be charged with a registration fee of One Thousand One Hundred Ninety-Five Pesos (Php1,095.00) to cover the honoraria, transportation and accommodation of the resource speakers, meals, snacks and other operational expenses.

- 7. Registration fee, travel and other related expenses of the participants shall be charged against local funds, journalism funds, GPTA funds or any other source of funds subject to the usual accounting and auditing rules and procedures.
