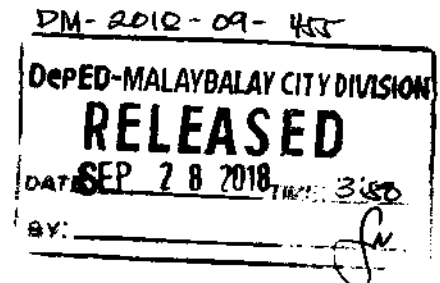

**YOUTH ORGANIZATIONS' REGISTRATION PROGRAM  
OF THE NATIONAL YOUTH COMMISSION**

1. The Department of Education announces the **Youth Organizations' Registration Program (YORP) of the National Youth Commission (NYC)**, which is mandated to register, help and facilitate the establishment of youth organizations and youth-serving organization through nationwide registration. This is pursuant to Republic Act No. 8044 otherwise known as Youth in Nation-Building.

2. In line with the registration, the NYC is currently implementing a more responsive YORP to encourage all youth organizations and youth-serving organization in the Philippines to register. Under the YORP, members of registered organizations with NYC will have the following privileges:

- a. access to different youth service providers;
- b. priority on invitations for local and international programs and activities;
- c. opportunity to meet other YORP beneficiaries in various youth events;
- d. involvement in advocacy campaigns;
- e. serve as resource person and key informants during consultations on policy issues; and
- f. benefit from experienced trainers and resource persons during conduct of seminars, trainings and workshops.

3. The guidelines, forms, steps on the registration and other relevant information about the program can be accessed to <http://yorpnyc.org.ph>. The NYC area officers are also willing to conduct an orientation with youth leaders.
