SECOND NATIONAL CLIMATE CHANGE CONFERENCE

1. The Department of Education (DepEd) through the Disaster Risk Reduction and Management Service (DRRMS), will host the **Second National Climate Change Conference** with the theme **Climate Action for Sustainable Development: Driving Change in Philippine Schools** from November 19 to 20, 2018 in Pasay City.
 2. The conference aims to:
 - a. increase awareness of stakeholders on the impacts of climate change to children and the youth;
 - b. provide a platform to share research activities on climate change adaptation, best practices, and innovations in schools; and
 - c. encourage the engagement of students and teachers in climate change adaptation activities within schools for building climate change resiliency.
 3. The conference will showcase researches and student projects related to climate change adaptation and mitigation through a research forum and a student exhibit.
 4. The target participants for the research forum are teachers and researchers from public and private schools, as well as DepEd DRRM coordinators, DRRM practitioners, climate change advocates and senior high school students from public and private schools. Available slots are limited.

2nd National Climate Change Conference

Conference Theme:

Climate Action for Sustainable Development: Driving Change in Philippine Schools

The Disaster Risk Reduction and Management Service (DRRMS) of the Department of Education (DepEd) is inviting teachers from public and private schools, DepEd DRRM Coordinators, practitioners, climate change advocates and academicians to share their research and submit their **abstracts** on climate change adaptation and mitigation in schools in the following themes:

Theme 1: Policy Development and Management in CCA

This is a broad theme covering issues, challenges, effective practices, status reports on the development, adaptation or localisation of climate change adaptation and mitigation policies in schools. It aims to showcase researches on how schools provide an avenue for national and international policies to be integrated in the school system. It also seeks to highlight the monitoring and assessment of the effectiveness of these policies in changing perspectives and views on climate change to the school's stakeholders.

Theme 2: Experiences and Innovations on Climate Change Adaptation in Schools

This theme covers product innovations, innovative practices, new methods and approaches that are utilised or introduced to raise awareness on climate change and to promote climate change adaptation in schools. This includes the use of technology in the classroom, bridging climate change issues and the curriculum, climate resilient school improvements on infrastructure, web technologies. It also highlights the integration and interplay of climate change adaptation with the various players, issues, concerns, and challenges in the education system with emphasis on resilience education, inclusive education, curriculum design and development, educational trends, barriers to teaching and learning, and student participation and engagement.

Theme 3: Community Linkages and Networking for CCA in Schools

This theme aims to present documented researches on the interactions and partnerships between schools, national government agencies, national and international non-government organisations, local government units, businesses, and other policy, practice, and research communities. It seeks to share and exchange knowledge and showcase projects that demonstrate how these groups collaborate to co-produce knowledge on around climate change adaptation.

Abstract submissions on other CCA or DRRM related topics are also highly encouraged.

Types of contributions:

You can present your projects in two modalities:

- **Oral presentation:** Each presentation will last 15 minutes and will be presented in parallel thematic sessions. The presenter delivers their research to their audience verbally, accompanied by a PowerPoint slideshow.
- **Poster presentation:** Your poster will be exhibited during the conference poster session. Poster sessions will provide an opportunity for authors to display the results and conclusions of their papers. Authors are invited to present their works

face to face with individuals and small groups. Posters are limited to a maximum size of 36" by 48" (vertical).

Submission Guidelines:

- All abstracts must be submitted in English.
- Submit a 250-word abstract containing the introduction, objectives of the study, methodology, results and findings, conclusion, and recommendations. It should end with three keywords on the topic investigated.
- The following should appear prior to the abstract part: research title, researcher/s name, position and affiliation, researcher/s email address/es. (See template)
- All text will be in Times New Roman 12, 1.5 line spacing, normal margin in an A4-sized paper.
