SUPERVISION BY EDUCATION PROGRAM SUPERVISORS AND

PUBLIC SCHOOLS DISTRICT SUPERVISORS

- 1. Corollary to Regional Memorandum No. 66, s. 2013 through Regional Memorandum No. 19, s. 2017 and in adherence to the prescribed functions of the Supervisors under the rationalization Program, this Office hereby directs the field for the adaptation of the tool and conduct of Instructional Supervision by the parties involved.
- 2. DepED Region 10 IS FORM 2017, attached as Enclosure 1, serves as basis in providing Technical Assistance for School Heads by Supervisors.
- 3. All EPSs and PSDSs target at least eight (8) sessions of Instructional Supervision for a month with at least two (2) sessions for a week. However, they are allowed from attaining more than the target number per month in the exigency of the task with the consideration that only one (1) day will be conducted to the same school head in a week.
- 4. Further, all instructional supervisions for the given period will be referred to a duly approved School Head's Instructional Supervisory Plan by the Chief, Education Supervisor-CID using the prescribed form in Annex-ISP-A, attached as Enclosure 2, to be submitted every last week of the month prior. In case the School Head is not available as scheduled information should be relayed ahead to the assigned EPS or PSDS.
- 5. Moreover, Instructional Supervisory Reports by the Supervisors (SHOGA) and by the School Heads (TOGA) shall be accomplished and submitted by the end of a

month to the Curriculum and Implementation Division , ATTENTION: Ralph T. Quirog, Chief, Education Supervisor-CID.




