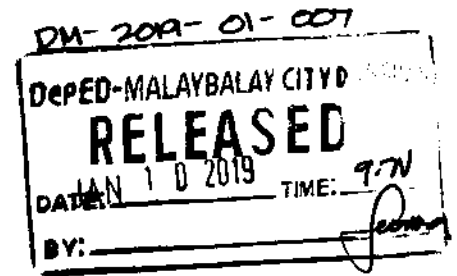

SUBJECT: 2019 METROBANK- MTAP- DEPED MATH CHALLENGE

1. Relative to DepEd Memorandum No. 191, s. 2018 entitled 2019 Metrobank-MTAP-DepEd Math Challenge the following are the schedule:

Competition Phase	Date
<b>Elimination Round</b>	January 17,2019 Elementary Level January 18, 2019 Junior High School Level
<b>Division Team Finals</b>	February 7, 2019 Elementary Level February 8, 2019 Junior High School Level

2. The overall objective of the competition is to contribute in improving the quality of Mathematics education in the Philippines. Specifically, it aims to:

A. Awaken greater interest in Mathematics among elementary and secondary students in both public and private schools all over the country;

- B. Encourage students to strive for excellence in Mathematics;
- C. Discover mathematical talents among the students; and
- D. Develop the values of hard work, perseverance, honesty, teamwork and sportsmanship.

3. The contestants are all bonafide students enrolled in Grades 1 to 10 in any Public and Private School who are registered online. Only three (3) pupils/students per grade level shall represent each school, for both public and private.

4. The Division Elimination Round-Elementary shall be conducted at Casisang Central School, Casisang, Malaybalay City and the Junior High School at Casisang National High School, Casisang, Malaybalay City for both Public and Private Schools.

9. The Opening Program for the Division Elimination round and Finals should be made at **8:00 am** where the package of test questionnaires shall be **opened publicly** and to be witnessed by the Branch Manager or Schools Division Superintendent.

10. The Team Orals should be conducted in three (3) different venues (Grades 1-2 in one Venue, Grades 3-4 in another Venue and Grades 5-6 in another Venue) while High School in two (2) different Venues ( Grades 7-8 in one venue and Grade 9-10 in another venue). The competition should be held simultaneously, preferably on the stage, inside the gym or any function room that can accommodate audience for the competition.

10. The **Division Finals Elementary** shall be conducted at **Sumpung Central School, Sumpung, Malaybalay City** while the **Secondary** shall be at **Bangcud National High School, Malaybalay City**. The following schedule of competition shall be followed:
