

SUBJECT: CONDUCT OF CY 2019 1ST QUARTER NATIONWIDE

SIMULTANEOUS EARTHQUAKE DRILL

1. 1st Quarter	21 February 2019	Iloilo City, Panay Island
2nd Quarter	20 June 2019	Bayugan City, Agusan del Sur
3rd Quarter	08 August 2019	Ormoc City, Leyte
4th Quarter	14 November 2019	Calapan City, Mindoro

The objectives of the Quarterly NSED are:

- 1. To evaluate the awareness and readiness of learners and DepEd personnel to earthquakes; and
- 2. To evaluate the coordination and communication mechanisms during evacuation procedures and response.

Submission Report Guidelines for the 2019 Quarterly Nationwide Simultaneous Earthquake Drills

All Schools, Schools Division offices, and Regional offices must follow the guidelines below or reports will not be accepted.

- 1. School DRRM Coordinators will submit the reports only to respective Division DRRM Coordinators not later than two (2) days after the Quarterly NSED.
- 2. Division DRRM Coordinators will consolidate NSED reports from School DRRM Coordinators and will submit only to respective Regional DRRM Coordinators, with copy provided to their respective Schools Division Superintendents, not later than ten (10) days after the Quarterly NSED.
- 3. Regional DRRM Coordinators will consolidate NSED reports from Division DRRM Coordinators and will submit to the DRRMS, with copy provided to their respective Regional Directors. 

- 3. To test the coordination and communications mechanism during response operation;
- 4. To understand the command and control mechanism in emergency and disaster operations at the DRRMCs.

.All RDRRMC member agencies and Chairpersons of all LDRRMCs are enjoined to spearhead the conduct of earthquake drill in their areas of jurisdiction and submit after activity report 15 days after the conduct of the drill to the Office of Civil Defense Regional Office-10 through electronic mail at ocdr10@gmail.com.
