- 1. This refers to the school building maintenance. The following are the observations:
 - a. Markings on ID Numbers on roofings. The Educational Support Services Division (ESSD) reiterates and enforces the need for proper markings of school identification numbers based on the following specifications per DepEd Order No. 64, s. 2017 dated December 15, 2017 entitled Establishing the Minimum Performance Standards and Specifications for DepEd School Buildings and Regional Memorandum No. 325, s. 2018 dated June 18, 2018.
- a.l., Section V.m. states that Roof Markings shall be painted on the main buildings of the tallest building of the school. They shall include the DepEd logo and School Identification Number.
 - a.2. Details and specifications shall be as follows:

DepEd Logo "Refer to DepEd Order No. 69, s. 2003 entitled DepEd Logo"	3.80m Height 7.60m Length	Existing DepEd Logo Design
School J.D. Number	2.00m Height 0.30m Thick	Blue with Color White Outline

The Educational Support Services Division (ESSD) hereby enforces the proper markings of school identification numbers based on the following specifications per DepEd Order No. 64, s. 2017 dated December 15, 2017 entitled Establishing the Minimum Performance Standards and Specifications for DepEd School Buildings:
 - A. Section V.m. states that Roof Markings shall be painted on the main buildings or the tallest building of the school. They shall include the DepEd logo and School Identification Number.
 - B. Details and specifications shall be as follows:
