The issuance of these guidelines aims to integrate and further institutionalize the primary objective of the enhanced Basic Education Act of 2013 that upholds the overall quality of basic education in the country by hiring highly competent teachers and to advocate the Department's mandate under the Magna Carta for Public School Teachers (RA 4670).
- 4. As provided in DepEd Order No. 7, s. 2015, an applicant shall submit to the head of the Elementary and Junior High Schools a handwritten application supported by the following documents:
 - CSC Form 212 (revised 2017) in two copies with the latest 2x2 ID picture
 - Certified photocopy of PRC professional identification Card

- Certificates of specialized training, if any
- Certified copy of voter's ID
- NBI Clearance
- Omnibus certification of authenticity and veracity of all documents submitted, signed by the applicant (form attached herein)
