EXECUTIVE ORDER NO. 76

Series of 2020

CREATING AND MOBILIZING THE RETOOLED COMMUNITY SUPPORT PROGRAM (RCSP) TEAM FOR THE OPERATIONALIZATION OF RCSP, PROVIDING FOR ITS COMPOSITION, ROLES AND RESPONSIBILITIES, AND FOR OTHER PURPOSES

WHEREAS, Article II of the 1987 Constitution indicates the following State principles and policies:

- i. The Philippine renounces war as an instrument of national policy;
- ii. The maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy; and
- iii. The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991, specifically Sections 17, 384, 440, 448, 458 among other pertinent provisions provide the roles of the local government units in the delivery of basic, regular, and direct services within its territorial jurisdiction;

WHEREAS, President Rodrigo Roa Duterte, through Executive Order No. 70, orders the institutionalization of the Whole-of-Nation Approach as a government policy for the attainment of inclusive and sustainable peace, addressing the root causes of local armed conflict by prioritizing the delivery of basic government services, social development packages, and construction of needed infrastructures with the end-in-view of ushering inclusive development in the pursuit of the country's peace agenda.

WHEREAS, the Retooled Community Support Program (RCSP) was formulated to address the identified issues of the community by closing the governance and development gaps through provision of needed government PPAs while ensuring that development is sustained and peace is being promoted.

WHEREAS, the DILG Memorandum Circular 2019-169 entitled *Guidelines on the Implementation of the Retooled Community Support Program (RCSP)*, provides that RCSP Teams shall be created from the provincial, city and municipal level to spearhead the operationalization of the RCSP;

NOW THEREFORE, I, FLORENCIO T. FLORES, JR., Mayor of the City of Malaybalay, and Chairman of the City Development Council and City Peace & Order Council by virtue vested in me by law, do hereby create and mobilize the "RETOOLED COMMUNITY SUPPORT PROGRAM (RCSP) TEAM, to wit:

SECTION 2. ROLES AND RESPONSIBILITIES

Section 2.1 The LCE as Head of the RCSP Team

The LCE shall serve as the Head of the Task Team and shall champion the cause to be at the forefront of the stride of bringing the government interventions to the people through RCSP. The Head shall also be in-charge with the deployment of RCSP Team to the target barangays for immersion and ensure that development initiatives are properly delivered, immediate needs properly addressed and long-term needs are properly programmed for funding and implementation.

Section 2.2 Retooled Community Support Program (RCSP) Core Team

The RCSP Core Team shall be the unit that directly provides all necessary tactical, technical, logistical, and administrative assistance to the RCSP Head.

Section 2.3 Citizenship and Community Participation Team (CCPT)

The CCPT is the Team tasked to organize the Citizen Movement by mobilizing communities into sectoral groups and usher them to participate in all sectoral dialogues/solution-seeking tables aimed to validate the governance and development gaps of the communities and identify the needed government interventions to address them.

Section 2.4 Basic Services Delivery Team (BSDT)

The BSDT is the team tasked to serve as the primary bridge of the RCSP Team to the government.

Section 2.5 Peace, Law Enforcement and Development Support (PLEDS) Team

The PLEDS Team is tasked to conduct clearing operations one week prior to the actual send-off of the RCSP Team, ensure perimeter security during the entire duration of the immersion, and continuous sanitation of the community from terrorist threats during the implementation and provision of needed government interventions.

SECTION 3. RELATIONSHIP OF THE CITY DEVELOPMENT COUNCIL AND CITY PEACE AND ORDER COUNCIL TO THE RCSP TEAM

The Development Council and Peace and Order Council shall maintain a vital linkage to the RCSP Task Team for the purpose of programs and projects coordination. The Councils shall focus on screening and prioritizing needed government intervention that must be included in the Local Development Investment Program (LDIP). Furthermore, the RCSP Team must also ensure that identified PPAs shall be implemented by securing available funding under all available sources.

SECTION 4. THE RCSP OVERLAPPING PHASES AND SUGGESTED TIMELINES

The implementation of the RCSP follows an operational methodology with the suggested phases and timelines as follow:

1	Shape	Organization of the RCSP Team and Core Team	Week 1-2
2	Access	Identification of development gaps and needed government interventions	Week 3-4
3	Transform	Implementation of priority programs and projects identified by the community based on the analysis of issues and gaps	Week 4-5
4	Sustain	Empowerment of communities, strengthening of BBIs, and capacity of barangay in the crafting of BDP	Week 5 - onwards
5	Monitor	Mobilization, hand-over and sustainability	Week 8 - onwards
