As agreed in the Management Consumitee meeting on Lebrary, 7, 2020, included Attains has requested the central office and regard directors for information on commental concerns reading from the dependent to which they may need legal assistance from Cannal Office Legal Attens. Nonetheless, even prior to receipt of their response, and considering the proximity of the national activities, Legal Affairs is already undertaking negotiations with Philippine Ambies and Cebu Pacific to make a special arrangement for participants in the said events, including students, teachers, DepEd personnel, and parents, among others, who have problems rebooking/refunding their plane tickets, which were purchased without option for refund or rebooking.

In view of this, this Office would like to request for the following:

1. From OUCI and OUA

Details pertaining to the passengers per activity, who are in need of special arrangement with the airlines to allow rebooking/refund, as follows:

- 2. Name of passenger appearing on the plane ticket
- b. Indicate if student, teacher, DepHd personnel, parent, judge, others
- c. National activity to be attended (NSPC, NFOT or NSIF)
- d. Airline
- e. Booking reference number (Cebu Pac) or Confirmation number (PAL)
- f. Route and date of travel (e.g. Iloilo-Manila, February 15, 2020; Manila-Iloilo, February 18, 2020)
- g. Indicate request: rebook or refund
- h. A statement that "I consent to the collection of the above personal information to request for rebooking/refund of my plane ticket."
- Total number of persons needing special arrangement per activity (NSPC, NFOT or NSTP)
- How it will be validated/certified that the passenger is a participant in the activity

This Office has coordinated with OUCI (an well as the Bureau of Carriculum Development and Bureau of Learning Delivery) on their proposed structure for collection of the data and certification by the Schools Division Superintendent, and with OUA for the creation of template and use of technology to facilitate the collection. In the interest of time, this Office requests direct confidention between the OUCI and OUA or their respective focal bureaus/service to complete the collection at the soonest possible time.

This Office would appreciate receiving the data for NSTF on February 6, 2020 and for the NSPC and NFOT on February 7, 2020. Kindly arrange the data per tegion for every activity.

- 2. From the Office of the Chief of Staff/Undersecretary for Public Affairs Service
 - a. Assistance to possibly package the special arrangement with the airlines sa a form of "sponsorship" whereby their assistance to DepEd's constituents will be acknowledged during the activities
