**FULL IMPLEMENTATION OF THE THIRD SET OF POLICY DIRECTIVES
OF THE DEPED TASK FORCE COVID-2019
DM 023, S 2020**

To: **Schools Division Superintendents**
This Region

1. As a response to DM 023, s. 2020 on the developments to contain the spread of Corona Virus Disease 19 (COVID-2019), the Department of Education (DepEd) Region X fully implements the appropriate changes in the measures for prevention and control of this virus in all offices and schools in the respective divisions while all other provisions of DM 015, s. 2020 titled First Set of Policy Directives of the DepEd Task Force NCOV and DM 021, s. 2020 titled Second Set of Policy Directives of the DepEd Task Force NCOV remain.
2. This Office directs all Schools Division Offices (SDOs) to reiterate and elaborate the travel measures and restrictions in the Enclosure No. 2 of DM 015, s. 2020 while giving emphasis to the mandatory self-quarantine for 14 days from the date of arrival, which shall be charged to the leave credits of the personnel while for the learners shall be provided alternative delivery mode (ADM) of education.
3. Resumption of the conduct of all national, regional, and/or off-campus activities may be started on February 24, 2020 but with emphasis on precautionary measures identified by DepEd and the Department of Health (DOH). Weekly Health situation Reports must be submitted by SDOs while adequate supply of water, soap, hand sanitizers, alcohol, and maintenance of cleanliness must remain a priority in all public schools based on the third set of policy directives of the Department Order. Private schools are highly encouraged in the interest of public health to adopt the same precautionary measures.
4. Immediate and wide dissemination of this Memorandum is desired.
