  - Certified copy of the Voter's ID or any proof of residency as deemed acceptable by the Division Selection Committee
  - Certification from the tribal chieftain (if applicable)
  - Medical Certificate (fit to work/travel to remote areas)
  - Service Record/Certification signed by the appropriate authority for relevant teaching experience (preferably ALS related teaching experience)
