DISSEMINATION OF EXECUTIVE ORDER NO. 79, S. 2020 RE: AN EXECUTIVE ORDER PRESCRIBING THE MEASURES TO BE IMPLEMENTED IN THE CITY OF MALAYBALAY TO PREVENT THE ENTRY AND SPREAD AND TO CONTAIN THE CORONA VIRUS DISEASE

(COVID-19) IN THE CITY OF MALAYBALAY

- 1. In view of the increasing number of cases spreading to various territories, confirmed human-to-human transmission, and the Presidential declaration of the nationwide State of Public Health Emergency, this Office hereby informs the field of the Executive Order No. 79, s. 2020 re: An Executive Order prescribing the measures to be implemented in the City of Malaybalay to prevent the entry and spread and to contain the Corona Virus Disease (Covid-19) in the City of Malaybalay, content of which is self-explanatory.
- 2. Suspension of classes in all levels in public and private schools effective March 16, 2020 to March 28, 2020, subject to weekly review by the Inter Agency Task Force for COVID-19.
- 3. All Public and Private Elementary and Secondary School Heads are enjoined to strictly follow the policy directives of the department.

EXECUTIVE ORDER NO. 79 Series of 2020

AN EXECUTIVE ORDER PRESCRIBING THE MEASURES TO BE IMPLEMENTED IN THE CITY OF MALAYBALAY TO PREVENT THE ENTRY AND SPREAD AND TO CONTAIN THE CORONA VIRUS DISEASE (COVID-19) IN THE CITY OF MALAYBALAY

WHEREAS, on March 08, 2020, President Rodrigo Roa Duterte, through Presidential Proclamation No. 922, declared a State of Public Health Emergency throughout the Philippines in view of the outbreak and local transmission the Covid-19 in the Philippine;

WHEREAS, the said presidential issuance enjoined the local government units to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the Covid-19 threat;

WHEREAS, on March 12, 2020, President Duterte has informed the public that the Department of Health has raised the public health alert level to Code Red Alert Sub Level 2, the highest alert level for public health crisis;

WHEREAS, the declaration of the State of Public Health Emergency throughout the Philippines and the raising of the alert level to Code Red Alert Sub Level 2 necessitates the adoption of measures to prevent the entry and spread of the Covid-19 and the containment thereof in the City of Malaybalay;

WHEREAS, the Malaybalay City Inter Agency Task Force on Covid-19 has passed Resolution No. 01, s. 2020, adopting measures to be implemented in the City of Malaybalay to prevent the entry and spread and the containment of Covid-19 in the City Malaybalay;

NOW THEREFORE, I, FLORENCIO T. FLORES, JR., by the power vested in me by law as City Mayor of Malaybalay City, Bukidnon, hereby ORDER for IMMEDIATE IMPLEMENTATION in the City of Malaybalay, Bukidnon, the following:

- 1.) All public and private offices are hereby required to institute preventive measures in their respective offices by providing alcohol/ hand sanitizers, thermal scanners, if available, and other sanitary measures to their clients and employees;
- Cancellation of all activities involving gathering of large number of participants. However, activities which could not be postponed nor cancelled shall secure clearance from the City Health Office (if regulated by the City Government) and/or shall strictly observe precautionary measures during the activity (e.g. religious activities);

- 3.) Suspend all classes for all levels in public and private schools for two weeks, effective March 16, 2020 to March 28, 2020, subject to weekly review by the IATF;
- 4.) Private business establishments, such as, but not limited to, supermarkets, restaurants, eateries/ carenderias, cafes, hotels, inns, computer shops, barber shops, parlors/ salons and other similar places/ businesses which cater to a large number of consumers/ patrons are also required to provide alcohol/ hand sanitizers and other sanitary measures to their clients and employees;
- 5.) All persons residing in the City of Malaybalay who have travel history for the past fourteen (14) days to countries and areas in the Philippines with confirmed Covid-19 cases shall observe the following protocol:
 - a.) If the person has no symptoms such as cough, fever or headache shall be considered as Person Under Monitoring (PUM) and shall observe self-guarantine for fourteen (14) days;
 - b.) If the person has experienced any of the above-mentioned symptom/s, he/she shall be considered as Person Under Investigation (PUI) and shall be required to undergo medical check-up;
- 6.) Hospitals and other medical professionals are required to comply with the orders and directives of the Department of Health on the matter;
- 7.) All persons are enjoined to practice proper hygiene (frequent washing of hands, etc.), social distancing and coughing etiquette;
- 8.) All business establishments are prohibited from increasing the prices on goods/ medical supplies (e.g. alcohol, hand sanitizers, body thermometers, thermal scanners and the likes) essential to prevention and spread of Covid-19;
- 9.) Public utility vehicles shall regularly sanitize their units;
- 10.) The City Health Office, the City Public Information Office and the barangay officials shall lead the dissemination of information and educational materials on Covid-19 to the public through all forms of media (print, broadcast, and social media);
- 11.) The City Health Office shall inform the barangays on the proper protocol in the handling of persons exhibiting symptoms of Covid-19;
- 12.) Individuals are strongly advised to exercise prudence and restraint in their social media postings/ sharings;
- 13.) The City Health Office may call on the Philippine National Police and other appropriate national agencies to assist in the enforcement of these measures

14.) Temporary closure of public tourist spots in the City, particularly Mt. Capistrano Mt. Range, Basakan District, Eagle's Lodge at Brgy. Dalwangan, Aninimpan Ridge at Barangay Casisang and Two-Trees spot, Brgy. 9.

Further, all orders and issuances made by the President of the Republic of the Philippines, the Secretary of the Department of Health and other concerned offices on the subject matter are deemed incorporated and read into this Order.

This Order shall take effect immediately until revoked/ lifted.
