DISSEMINATION OF REGIONAL MEMORANDUM No. 255:

INTENSIFYING THE WaSH IN SCHOOLS (Wins) PROGRAM

1. All Public and Private Elementary and Secondary School Heads are enjoined to intensify the implementation of SBM-WinS program by taking notice of the checklists and support COVID-19 control measures.

- 2. - 4. Schools are also encouraged to strengthen and expand partnership in the provision of hygiene kits to learners and installation of additional group/individual handwashing facilities.

REGIONAL MEMORANDUM No. 260 s. 2020

INTENSIFYING THE WaSH IN SCHOOL (Win8) PROGRAM

To: Schools Division Superintendents
Division SBM-WinS Coordinators
Public Schools District Supervisors
All Public and Private Elementary and Secondary School Heads
All other concerned

- 1. COVID-19 (Corona Virus Disease) pandemic has placed the whole nation in crisis. Learners and teachers have become vulnerable to acquiring the disease when exposed to the public, threatening to compromise the teaching-learning process. Proper handwashing, sanitation, and hygiene are the best defense against the spread of this pandemic and are what School-Based Management, Water, Sanitation and Hygiene in School (SBM-WinS) advocate. Washing of hands really saves lives.
- 2. Hence, this Office enjoins all schools to intensify the implementation of SBM-WinS program by implementing the following but not limited to:
 - a. All schools must install handwashing facilities with soap and water at the entrance for the learners, teachers, and school visitors to handwash upon entering and leaving the school. Group handwashing facilities must also be provided near the school building for easy access of learners before entering the classroom.
 - b. Mandatory washing of hands upon entering the school, classroom, and when leaving for home must be done regularly. Strict practice of handwashing during critical times, before and after eating, after using the toilet, before preparing foods, after playing/gardening/working, and after throwing the content of garbage bins must be observed. Handwashing shall be executed the "S.C.H.O.O.L." Handwashing technique (Attachment 2) with "Wash Our Hands" song (Attachment 3) to comply with WHO 60 seconds handwashing time.
 - c. Alcohol and other disinfectant must be available at the entrance of schools.
 - d. School must be equipped with thermal scanner to monitor body temperature of everyone coming in to schools.
 - e. Foot bath must be installed at the school's entrance for learners, teachers, and visitors to disinfect footwear before entering.
 - f. All schools must organize liquid soap making activities for sustainability of supplies.
 - g. Require everyone to use face masks at all times. School must be ready to provide if learners forget to bring or cannot afford to have one. Schools must implement measures to ensure compliance without depriving learners of their right to enter the school and attend classes.

h. All schools and Schools Division Offices (SDOs) are advised to install "hands-free" handwashing facilities to minimize if not totally avoid transmission of germs and viruses.

i. All learners must be provided with personal hygiene kits, adding a washable face mask on the top of the regular content of WinS hygiene kits.

- j. For existing group handwashing facilities, other faucets/punch holes may be salvaged/covered to maintain physical distancing while doing the handwashing activity.
- k. All DepEd personnel are encouraged to take up WHO online course on Emerging respiratory viruses, including COVID-19: methods for detection, prevention, response and control @ openwho.org/courses/introduction-to-
- All private schools are likewise encouraged to intensify the implementation of WinS program.
- Divisional SBM-WinS Technical Working Group and Coordinators are tasked to monitor the WinS readiness of schools using the tool WinS Readiness Checklist for the Opening of Classes 2020 amidst COVID-19 pandemic (Attachment 1). Collection and consolidation of the tool results shall be submitted to the Regional Office (RO)before the opening of classes on August 24.
- Moreover, all School Improvement Plan (SIP) shall be revisited and Annual Implementation Plan (AIP) be revised to prioritize supplies, projects, and initiatives to combat COVID-19 pandemic.
- Schools are also encouraged to strengthen and expand partnership in the provision of hygiene kits to learners and installation of additional group/individual handwashing facilities.

This tool must be administered twice this year. First is on July 2020 (items 1-14 only). Results will guide the schools on what are yet to be prepared/accomplished, while SDO can use the result for planning in the provision of technical assistance to schools. The second round is to be done in August (all items 1-17) to determine whether all schools are ready for the opening of classes.

Palm to palm and cross fingers of both hands.






Rub back of hands and between fingers in vice versa.
