**STRENGTHENING THE INITIATIVES
OF ALL SCHOOL TASK FORCE COVID-19 IN REGION 10**

1. Responsive to the increasing local cases of COVID-19 in the region, the Department of Education (DepEd) Region X reiterates the important role of all School Task Force COVID-19, leading the initiatives to contain the spread of Corona Virus disease in all DepEd schools, consistent with the directive of the DM 015 s 2020 and RM 75 s 2020 for its full implementation on February 6, 2020.

2. Hence, this Office directs all Schools Division Offices (SDOs) to strengthen the coordination efforts of the Division Task Force COVID-19 with all school Task Force COVID-19 teams pertaining but not limited to the following:

- School preparation and contingency plans, including the triage system in school;
- Protection and promotion of school personnel wellbeing at work especially when work is at home;
- Contact tracing procedures which include the monitoring of all suspects, close contacts, and confirmed cases in each school;
- Continuous provision of guidance to all school personnel on the latest health protocols issued by the local health authorities and local inter-agency task force for COVID-19; and
- Documentation of all lessons learned and insights on school governance during pandemic for future school policy design and possible policy recommendation to the schools division or the regional office.
