**Subject: REVIEW OF THE FOURTH QUARTER SELF-LEARNING MODULES
(SLMs) VERSION 3**

Date: January 27, 2021

1. The Division is committed to provide learning resources to support modular approach in learning amidst this current situation through the reproduction of fourth quarter SLMs with the assistance of all districts.
2. To expedite the reproduction of fourth quarter SLMs, this Office directs the schools to review the assigned modules by doing the following:
 - a. Secure a copy of the assigned modules from the Division LRMD. Link will be sent upon request by the School LRMDS Coordinator/ICT Coordinator;
 - b. Should there be plenty of modules in one subject, consider the most important topics for 8 weeks based on MELCs (maximum number of modules per subject is 8);
 - c. To lessen the number of pages, remove the copyright page, title page, and reference page or any unnecessary contents. **Retain the front cover page, pasina/introduction page, content pages, answer key, and back cover page. Maximum number of pages should be 16. There**

should only be two modules per component of the MAPEH subject;

- d. Fix the module contents if distorted, such as misplaced images, big spaces, or no spaces between words, etc.
 - e. Always consult the Education Program Supervisors in-charge per learning area for advices or approval if there are issues/concerns about the module contents before making decisions for any changes/corrections.
 - e. In the event that the SLMs have no more issues, return the materials to the same link and attach them to the provided folder entitled 'Ready to Print' in Word and PDF formats; and
 - f. Materials shall be submitted on or before **February 12, 2021**. In the event that version 3 SLMs are not available, version 2 shall be used.
3. Assignment of modules for review is attached as enclosure.
4. **Grade 3 SLMs** shall be evaluated by the Division Conformance Review Team headed by the Education Program Supervisor/Public Schools District Supervisor assigned per learning area. **Version 4** of Grade 3 SLMs shall be uploaded on or before **February 12, 2021**.
