EXECUTIVE ORDER NO. 131 EX

PRESCRIBING HEALTH PROTOCOLS FOR RETURNING AN ORDER RESIDENTS AND TRAVELERS TO MALAYBALAY CITY AND FOR OTHER **PURPOSES**

WHEREAS, on February 26, 2021, the National Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID) has issued IATF Resolution No. 101, s. 2021, which prescribes new uniform guidelines for inter-local government travel protocols;

WHEREAS, on its March 03, 2021 joint meeting, the Malaybalay City COVID-19 Inter-Agency Task Force (IATF) and the Emergency Operations Committee (EOC) has recommended the adoption of the said travel guidelines, subject to some revisions;

WHEREAS, on the said meeting the both bodies has also recommended the lifting of restrictions on the operations of KTV and Sing-along establishments in the City of Malaybalay, subject to strict observance of minimum health protocols by these businesses;

NOW THEREFORE, I, FLORENCIO T. FLORES, JR., City Mayor of Malaybalay City, by virtue of the power vested in me by law, do hereby order the following:

1. TRAVEL TO MALAYBALAY CITY

- a.) All persons (returning OFWs, locally stranded individuals, tourists, visitors and the likes) traveling to Malaybalay City shall be required to report to the Emergency Screening Area (ESA) for medical evaluation thereat;
- b.) No traveller shall be required to go under quarantine unless they exhibit symptoms upon arrival and screening at the ESA:
- c.) Travel authority from the Joint Task Force COVID Shield and Health Certificates shall no longer be required:
- d.) Transport for returning residents from the airports and seaports shall no longer be provided, except for those resident individuals who are referred to the City Government of Malaybalay by quarantine authorities thereat (airports and seaports) for quarantine/isolation purposes;

2. USE OF INFORMATION TECHNOLOGY (IT) SOLUTIONS

- a.) The Safe, Swift and Smart Passage (S-PaSS) Travel Management System of the Department of Science and Technology (DOST) shall be adopted and implemented by the City Government of Malaybalay upon its availability;
- b.) All establishments, offices and businesses are encouraged to adopt, if feasible, the StaySafe.ph System as the primary contact tracing system for their respective offices and establishments;
- OPERATION OF KTV AND SING-A-LONG BUSINESSES The operation of of KTV and Sing-a-long businesses are now permitted in Malaybalay City, subject to the following conditions:
- a.) Strict observance of minimum public health protocols (face mask, social distancing, hand-washing, sanitation of equipment, etc.) by its employees and customers;
- b.) Only 50% of its customer capacity shall be allowed, provided that the 1-meter distancing is observed among its customers;

All concerned City Government officials, the Incident Management Team, the Malaybalay City Police Station and the barangay officials, barangay health emergency response teams (BHERTs) are hereby ordered to monitor and ensure the observance and compliance by all concerned.

This order shall take effect immediately.
