4. A prescribed activity is discussed in DepEd Order No.3, s.2018 and the kindergarten cut-off age should be followed as mandated in DepEd Order No.20, s.2018.
5. All school should strictly observe the COVID-19 health protocol as stated in the attached DepEd and Regional Memorandum.

REGIONAL MEMORANDUM

No. 114, s. 2021

EARLY REGISTRATION FOR SCHOOL YEAR 2020-2021

To: Schools Division Superintendents
Assistant Schools Division Superintendents
Curriculum Implementation Division Chiefs
School Governance and Operations Division Chiefs
Public and Private Elementary and Secondary School Heads
All Others Concerned

1. Regarding DepEd Order No. 3, s. 2018 (Basic Enrollment Policy), and DepEd Memorandum No. 8, s. 2021 (Deferment of the Conduct of Early Registration for School Year 2021-2022), this Office requires all public and private elementary/secondary schools and ALS Community Learning Centers of this Region to conduct early registration for kindergarten to Grade 12 and ALS Literacy Sessions from March 26 to April 30.
2. The activity is aimed at the following:
 - a. Ensure that all new entrants for kindergarten, Grades 1,7, and 11 learners in public and private elementary and secondary schools nationwide are registered for School Year 2021-2022;
 - b. Establish database of expected enrollees for SY 2021-2022 in order to prepare the needs of learners for instructional materials, school buildings, teachers, and other needs; and
 - c. Locate, identify, and register OSC and OSY in the community.
3. In the context of the prevailing COVID-19 public health emergency, the conduct early registration shall be done remotely in areas under General Community Quarantine (GCQ). In-person registration through parents or guardians may be allowed in areas under Modified General Community Quarantine (MGCQ), provided that physical distancing and health and safety protocols are strictly followed.

4. The following are reminders to ensure the effective implementation of early registration:

- a. All schools shall post their early registration activities on Facebook using hashtag **#R10earlyregistration2021**. Instructions on posting will be discussed in Attachment 1.
- b. All Schools Division Offices (SDOs) and schools shall prepare tarpaulins on early registration.
- c. The District ALS coordinators shall work closely with elementary and secondary school heads.
- d. Early registration data should be inputted in the Learners Information System (LIS).

5. Guidelines on the conduct of and requirements for early registration are discussed in DepEd Order No. 3, s. 2018 titled Basic Education Enrollment Policy.

6. Immediate and wide dissemination of this Memorandum is desired.

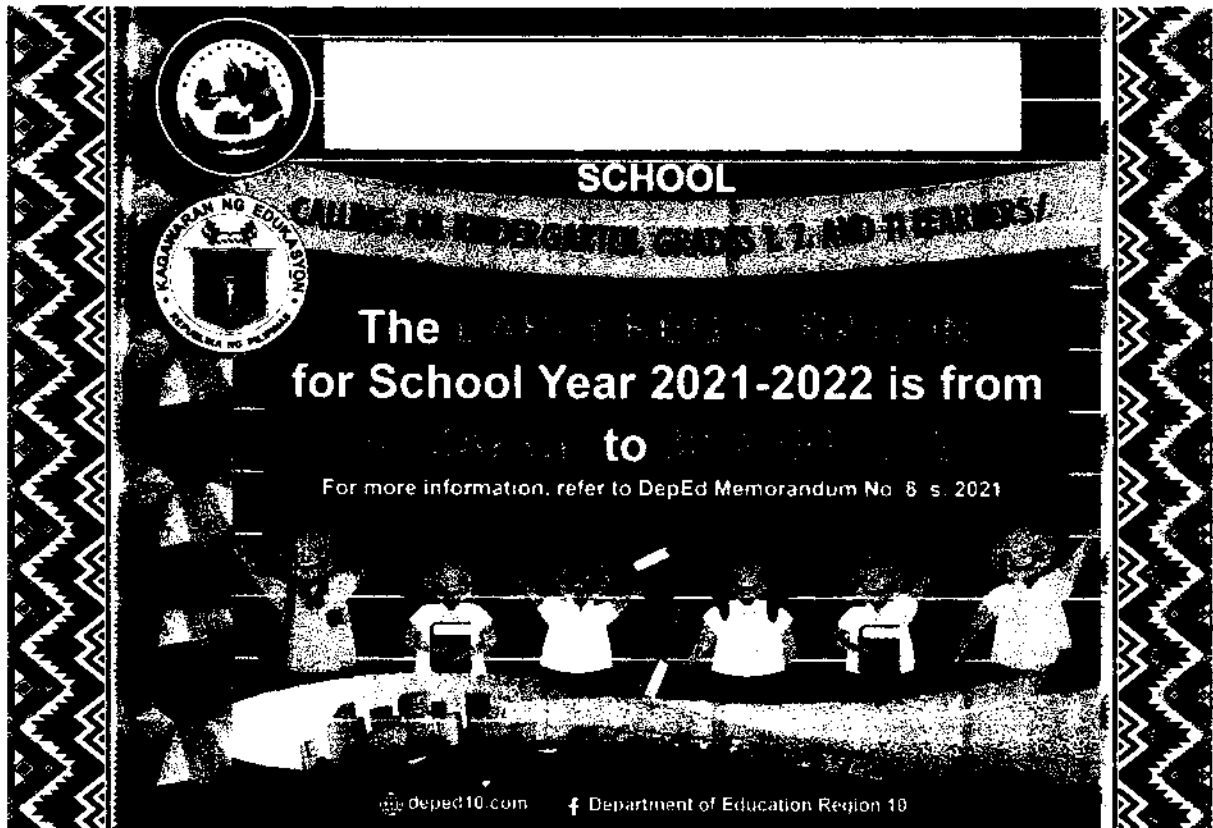

1. Hashtags turn topics and phrases into clickable links in your posts on your personal timeline or Page.
2. To make a hashtag, write # (the number sign) along with a topic or phrase and add it to your post.
#R10earlyregistration2021
3. When you click a hashtag, you'll see a feed of posts that include that hashtag. You may also see some related hashtags at the top of the page.
4. Please keep in mind:
 - A hashtag must be written as a single word, without any spaces.
 - You can include numbers in a hashtag, but punctuation and special characters (like \$ and %) won't work.
 - You can search for a hashtag using the search bar at the top of any page.

**DEFERMENT OF THE CONDUCT OF EARLY REGISTRATION
FOR SCHOOL YEAR 2021-2022**

Public and Private Elementary and Secondary School Heads
All Others Concerned

1. Given the major changes in the school calendar for School Year (SY) 2020-2021 where the start of school year was moved from June to October 2020, the conduct of early registration for SY 2021-2022 is deferred to **March 26 to April 30, 2021**.
2. As stipulated in DepEd Order (DO) No. 03, s. 2018 or the *Basic Education Enrollment Policy*, all incoming Kindergarten, Grades 1, 7, and 11 learners in all public elementary and secondary schools shall pre-register to allow the Department to make necessary preparations and adjustment of plans for the incoming SY. Grades 2-6, 8-10 and 12 are considered pre-registered and will not need to participate in the early registration. Private schools are encouraged to conduct their respective early registration activities on the same timeframe.
3. In the context of the prevailing COVID-19 public health emergency, the conduct of early registration shall be done remotely in areas under General Community Quarantine (GCQ). In-person registration through parents or guardians may be allowed in areas under Modified General Community Quarantine (MGCQ) provided physical distancing and health and safety protocols are strictly observed.
4. School authorities of public and private schools are mandated to strictly implement the Kindergarten cut-off age under DO 020, s. 2018.
