FIELD VALIDATION OF 2020 DIVISION BRIGADA ESKWELA BEST IMPLEMENTING SCHOOLS

1. Regarding Memorandum OU-LAPP NO. O-008, s. 2021 titled **Conduct of Brigada Eskwela (BE) Awards** and RM No.90 S. 2021 titled **Submission of Brigada Eskwela Best Implementing Schools**, this Office, through the Education Support Services Division (ESSD), will conduct an on-site validation to all awardees of the Divisional Brigada Eskwela Best Implementing Schools on March 22-26 and April 12-23.

2. The activity is aimed at validating the BE accomplishment reports of all elementary and secondary school winners in the divisional level prior to the submission of list to the Central Office (CO). It is likewise aimed at commending their worthwhile efforts at the regional level especially in the implementation of BE in engaging partners to support the implementation of the schools' and the divisions' Basic Education Learning Continuity Plans (BE LCPs).

3. The regional BE validating team shall base their evaluation on the following criteria:

- a. *Brigada Eskwela Partnership Engagement Activities* - 40%
 - b. *Resource Generated relative to the COVID-19 Situation* - 30%
 - c. *Bayanihan effort to support the BE LCP implementation* - 30%
- 100%


4. Moreover, as part of the implementation/integration of Equal Employment Opportunity Policy (EEOP) in the area of Rewards and Recognition (R&R) of the PRIME-HRM, EEOP shall be observed in the conduct of the BE Awards, that is, fair treatment of all regardless of age, sex, sexual orientation, gender, gender identity, civil status, disability, religion, ethnicity, and political affiliation, among others.
