SUBJECT: DIVISION UNIFIED SCHEME OF LEARNERS READING PROFILE FOR GRADES 1 TO 7 IN FILIPINO AND ENGLISH

1. Relative to **DepEd Memorandum OUCI-2020-307** re: Suggested Measures to Foster Academic Ease during the Covid-19 Pandemic through **Regional Memorandum No. 74, s. 2021** on Remedial Learning Activities to cover the least mastered competencies particularly on **READING**, the following are highly suggested as part of School-Based Reading Program Implementation:

a) conduct and procedure in the utilization of PHIL-IRI ASSESSMENT TOOL is inappropriate by this time, schools are to modify and use other strategy and or school-based approach to measure the learners' reading level;

b) mode of classification among Grades 1 to 7 learners' reading ability will be school-based however description and labeling of reading profile would be unified as **NON-READER, SLOW READER, AVERAGE READER** and **FAST READER**;

c) schools has the discretion of utilizing any available reading supplementary materials appropriate for the grade level as tool of measuring reading level but they have an option to use Early Grade Reading Assessment (EGRA) as per DepEd Order No 57, s. 2015 (downloadable) for Grade 1 learners and PHIL-IRI Reading Passages for Grades 2 to 7.

2. Conduct of **Pre-Test** and **Post-Test** are still required and data gathered will be submitted in the office using the template as Attachment I of this memorandum on or before
