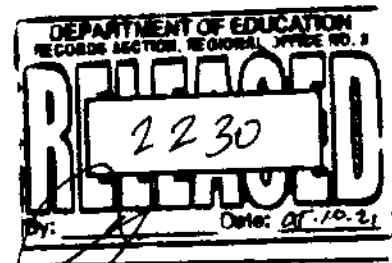



### NATIONAL CREATIVE PAINTING CONTEST

In celebration of the 2021 Quincentennial Commemorations in the Philippines, the Department of Education (DepEd), through its External Partnerships Service-Special Events Unit (EPS-SEU), shall conduct a **Creative Painting Contest**.

#### 1. OBJECTIVES

- 1.1 increase awareness on the life and heroism of Lapulapu and his men during the victory of the battle of Mactan on April 27, 1521;
- 1.2 serve as an inspiration for the Filipinos especially among our youth the bravery and courage shown by our battle of Mactan heroes in defending our freedom against foreign invaders led by Ferdinand Magellan; and
- 1.3 showcase the talents of the Filipino Youth, our learners, through visual arts.

#### 2. PARTICIPANTS

The creative painting contest is open for all Grades 4 to 6 learners enrolled during the SY 2020-2021 in any public and private elementary schools nationwide. The school should be duly recognized by the Department of Education.

The Regional and Schools Division Araling Panlipunan Supervisors (RSDAPSSs), are designated as heads of the Regional Quincentennial Committee (RQC /SDQC), Regional Supervisor Araling Panlipunan (RSAP) will be the members of the National Quincentennial Committee to oversee the identification, selection of entries in their respective areas.

**Each region shall submit five (5) entries only.** Champions from the previous competitions conducted by the External Partnerships Service-Special Events Unit (EPS-SEU) are discouraged to join the competition to give chance to others.

#### 3. SCOPE / THEME

The entries should depict the life, works and heroism of Lapulapu and how the youth of today can apply Lapulapu's wisdom, compassion, integrity, and love for this country and should be in line with this year's theme: "**Victory and Humanity.**"

4. **ENTRY SPECIFICATIONS**

Only entries submitted in correct and complete specifications and formats will be considered as official entries. Please take note of the following requirements to ensure that the entry satisfies the specifications of the contest:

- 4.1 The painting should be in a 15"x20" illustration board.
- 4.2 The contestant may use any medium of his/her choice, (e.g. oil pastel, crayon, and water color)
- 4.3 The painting must be described in one or two sentences. The description must be written and printed on a ½ A4 bond paper. This should be posted at the back of the entry together with the certification of enrollment (SY 2020 – 2021) duly signed by the Principal/School Head.
- 4.4 The Philippine Flag must not be used as background of the painting. If used as part, it should be placed in a conspicuous place to show its importance to the art work (Please refer to Sec. 39 Prohibited Acts under Republic Act (RA) No. 8491 titled "An Act Prescribing the Code of the National Flag, Anthem, Motto, Coat-of-Arms and other Heraldic Items and Devises of the Philippines.").

5. **CRITERIA**

5.1 Adherence to the scope, theme, and objective -----	40%
5.2 Creativity and Originality -----	30%
5.3 Composition-----	20%
5.4 Visual Impact-----	10%
<b>Total -----</b>	<b>100%</b>

6. **DETERMINATION AND ANNOUNCEMENT OF WINNERS**

The entry which will get the highest score shall be declared as the National Champion, the entry with the second highest score shall be declared as the first runner-up, and the entry with the third highest score shall be declared as the second runner-up, so on and so forth. The names of the winners and process on claiming their prizes shall be announced in a separate memo.

7. **SUBMISSION OF ENTRIES**

- 7.1 The deadline for the submission of entries will be on **June 4, 2021 at 5:00 p.m.**
- 7.2 Each entry must be accompanied by the following requirements:
  - 7.2.1 A certification from the principal that the contestant is enrolled in the current School Year (2020-2021); and
  - 7.2.2 Scanned image of the student registration form or ID, principal's ID and accomplished entry form.

The Regional and Schools Divisions MAPEH Supervisors (RSDMSs), are designated as heads of the Regional Quincentennial Committee (RQC/SDQC), Regional Supervisor Araling Panlipunan (RSAP) will be the member of the National Quincentennial Committee to oversee the identification, selection of entries in their respective areas.

**Each region shall submit five (5) entries only.** Champions from the previous competitions conducted by the External Partnerships Service-Special Events Unit (EPS-SEU) are discouraged to join the competition to give chance to others.

2. The entry should have a minimum of 10 and maximum of 15 participants including the conductor. Members may come from different public and private schools but should be within the area of their jurisdiction.
3. The contest piece will be "**Bagani**" a song written and composed by **Roel Rostata** and interpreted by **Pinopela**. The video should not have an introduction nor credits. ### **6.2 Concept and Development (25%)**

- 6.2.1 exceptional plot/idea development (story) must logically and be sensibly focused on the new normal situation of the country.
- 6.2.2 interest is developed and sustained at a high level.

### **6.3 Visual Interpretation/Creativity (25%)**

- 6.3.1 outstanding skill in showing imagination and creativity in content and production techniques.
- 6.3.2 superior attempt in creating a product that shows originality.
- 6.3.3 outstanding and imaginative skill in showing mood, style and artistic interpretation.

### **6.4 Technical (25%)**

- 6.4.1 lighting is creatively and effectively used.
- 6.4.2 audio is flawless and well balanced using ambient sound, music and/or sound effects effectively.
- 6.4.3 camera work is outstanding using shots and angles to provide impact.
- 6.4.4 editing is effectively used to enhanced message.
- 6.4.5 graphics/titles are used to enhance the topic or message.
