<sup>2</sup> For purposes of this event, a school leader under Category B refers to a person with experience in research supervision and school leadership/management, specifically in the field of research. He/She may not be designated/appointed as school principal/head/director, assistant principal/head teacher, teacher-in-charge etc., but is designated/appointed as Department/School Research Coordinator, Research Director/Head, etc. as evidenced by service records/certificate of employment.

## **QUALIFICATIONS for the Outstanding Research Management and Innovation (either for Basic Education or for Higher Education):**

In this award, the emphasis is not on the person or the applicant, but on the research management, or system, or project or product or innovation which was originally conceptualized and fully implemented by the applicant, and which benefited people in the classroom, school or the community. The qualifications for this award are as follow:

1. The author of the research management, or system, or project or innovation must be a Research Consultant of the ETCOR Educational Research Center at least before the deadline of application to the award/s (November 16, 2021) as evidenced by the valid Certificate as a Research Consultant and/or valid Certificate of Recognition as a Research Consultant;
2. The said author has a valid and updated teaching license (LET) or other acceptable government eligibility/license. For teachers in the higher education, the teaching license will not be required;
3. The said author must be in the field of education or in the academe (public and/or private) for at least five (5) months or one (1) semester as evidenced by service records/certificate of employment. The reason for the 5-month or 1-semester experience in the field of education is the fact that the conceptualization and implementation of a research management, or system, or project or product or innovation may not be dependent on the number of years of stay in the field of education. Younger employees may already be innovative even during the first semester/year of their stay in their institution. Further, the focus of the award is neither the applicant nor his years of experience, but the existence of a research management, or system, or project, or product or innovation.
4. At least a holder of a bachelor's degree from a reputable educational institution as evidenced by the Transcript of Records;
5. Must have no pending and/or should have not been found guilty of any criminal and administrative offense. Document to be submitted: NBI and/or police clearance (if available), or certification from the legal division or any other competent authority (Schools Division Superintendent, School Principal/Head/Director/HRMO) of the applicant.
6. Must have fully documented and implemented research management, or system, or project or product or innovation as evidenced by approved project proposal, proof of implementation, accomplishment reports (or patent, if applicable) and other documents that can support the success of the research management, or system, or project or product or innovation.
7. Other requirements aside from those enumerated above: (a) Letter of Intent either signifying interest to apply or to nominate the research management, or system, or project or product or innovation of another person, letter to be addressed to Dr. Adrian
