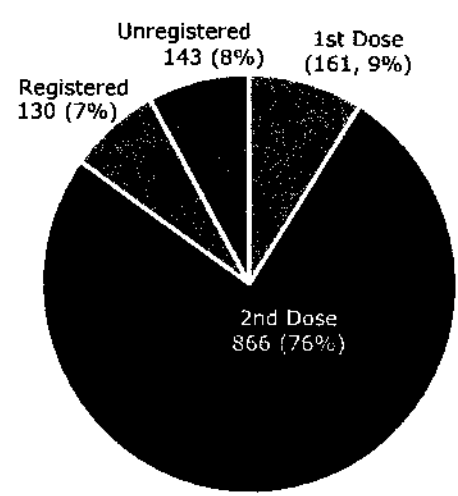
**STATUS OF VACCINATION IN DEPED (AUGUST 2021)**

The DepEd Task Force COVID-19 (DTFC), through its vaccination program representatives, provides the following updates on the status of vaccination in the Department.

**A. Vaccination Data Submitted by BHRD-EWD and Regional Focals**

**1. Central Office (as of 03 August 2021)<sup>1</sup>**

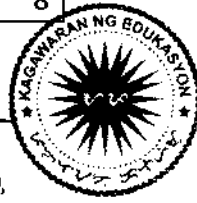
- Out of the eligible population based on the Personnel Division data (permanent, COS, consultants), 85% or **1,535** are already vaccinated, and most have received the second dose (76%).
- The numbers are mainly based on the submitted vaccination lists to the Bureau of Human Resource and Organizational Development – Employee Welfare Division (BHRD-EWD) and the data per the Pasig-LGU vaccination program.
- 07% are registered and awaiting schedule of vaccination, while eight percent (8%) remain unvaccinated and unregistered.

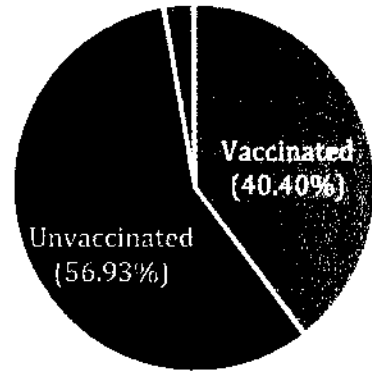

**2. Data collected from the Regional Offices<sup>2</sup>**

- The data, covering **952,426** personnel, are based on the submissions of the Regional COVID-19 Response/Vaccination Focals to the Bureau of Learner Support Services-School Health Division (BLSS-SHD) as of **24 August 2021**.<sup>3</sup>
- More than 40% or 384,752 field personnel are already vaccinated either with only the first dose or complete up to the second dose.
- Almost 57% or 542,194 field personnel remain unvaccinated. They are either already registered in their respective LGUs and awaiting their schedule or not willing to get vaccinated.

<sup>2</sup> Awaiting the resumption of the regular submission of vaccination data by Regional COVID-19 Response/Vaccination Focals, the BLSS-SHD requested from them their latest available vaccination data; 16 out of 17 regions were able to submit updated data until 24 August 2021, while the 17th region was able to provide updated data on 06 September 2021; note that the "cut-off" dates per region vary.

<sup>3</sup> Note that while some regions have more updated data after 24 August 2021, said data have not been reflected in this report.

<sup>4</sup> The Office of the Undersecretary for Administration (OUA) through the Information, Communications, and Technology Service (ICTS), issued OUA Memorandum No. 00-721-0093 titled *Mass Dissemination on Self-Reporting for COVID-19 Vaccination Tracker* to officially disseminate the vaccination tracker, accessible through the DepEd Mobile App, and enjoin personnel nationwide to use the tracker in reporting their vaccination status.

### C. Updates and Ways Forward

1. The DTFC, in coordination with the National Vaccination Operations Center (NVOC) and the Office of the Undersecretary for Field Operations (OUFO), has initiated the conduct of regional consultations with COVID-19 Focals up to the division level, to validate the submitted status of institutional arrangements with LGUs, discuss issues and concerns in establishing such arrangements, and recommend next steps and ways forward to help the region expedite the vaccination of teachers.

Consultations have been conducted in NCR and Region IV-A on 12 and 18 August 2021, respectively. A follow-up consultation with Region IV-A and the consultation with Region III are currently being scheduled.

2. Within the week, the DTFC representatives for vaccination (BLSS, BLSS-SHD, BHROD, ICTS) together with the OUFO will meet to finalize the data reporting mechanism on personnel vaccination to better inform policy and contribute to expediting the vaccination of teachers.
