Greetings from the Philippine Sports Commission (PSC)!

As the pandemic continues and public health measures are in place to contain the spread of COVID-19, it is challenging to implement our grassroots sports development program for the PWD community. To address this, the PSC will be conducting a **WEBINAR SERIES ON HANDLING AND TRAINING PARA-ATHLETES** and would like to respectfully invite members of the Department of Education.

With utmost consideration for the public's health and safety, this webinar series will be held purely online through the Zoom platform. This project will feature 3 subtopics, (1) Sensitivity Webinar on Handling and Training Para Athletes, (2) Classification of Para Athletes, and (3) Rights & Privileges of Para Athletes in the Philippines.

Second, the webinar on **Classification of Para Athletes**, to be held on 21 September 2021, aims to provide a holistic grasp of the proper classification of athletes, as it is important to ensure fair competition in Para Sports. This will be presented by Dr. Maria Concepcion Fabreo Anda, Vice President of the Integrated Philippine Association of Optometrists (NCR), and Dr. Raul Michael Cembrano of the Philippine Sports Association for the Differently Abled (PHILSPADA).

And lastly, the webinar on **Rights & Privileges of Para Athletes in the Philippines**, to be held on 22 November 2021, will be presented by Mr. Marc Edward D. Velasco, National Training Director of the Philippine Sports Commission and Mr. Michael Barredo of the Philippine Paralympic Committee
